**6. Motion to change the rules of ABC Friends Inc**

**Motion 4:** That changes to the rules of ABC Friends Inc be approved to support national consistency and alignment with the functions of ABC Friends Ltd (National) as follows:

**New Rule 3, Purpose:**

The purposes of the Association are:

- (1) to support and promote the cultural forms produced and broadcast by Australia's national public broadcaster, the Australian Broadcasting Corporation (ABC) by:
  - (a) informing and educating the Australian public about the cultural forms produced by the ABC including those that contribute to a national identity, inform and entertain the Australian public and reflect the cultural diversity of the Australian community;
  - (b) ensuring the ABC is adequately funded by Government to fulfil its role;
  - (c) ensuring the ABC remains independent of government influence, commercial sponsorship and advertising; and
  - (d) promoting the ABC's role in reflecting Australian culture in all its diversity.
- (2) to carry out any other activities which in the opinion of the Committee of the Association will further the foregoing objects.

**Replacing old rule 3:**

The purposes of the Association are:

- (1) to support the maintenance and advancement of the Australian Broadcasting Corporation (ABC)
  - (a) to fulfil to a high standard its role as an independent and comprehensive national public broadcaster;
  - (b) to be adequately funded by Government to fulfil its role;
  - (c) to remain independent of government influence, commercial sponsorship and advertising; and
  - (d) to promote Australian culture in all its diversity.
- (2) to carry out any other activities which in the opinion of the Committee of the Association will further the foregoing objects.

**New Rule 8(2) Subscriptions**

Membership categories and fees will be determined by the Committee as appropriate and in alignment with the membership categories and fees determined by ABC Friends Ltd.

**Replacing old rule 8(2)**

Annual subscriptions shall be such amount as is determined by the Annual General Meeting and until varied shall be:

- for students, pensioners and unemployed \$20 per annum or \$50 for three years;
- for ordinary members \$30 per annum or \$80 for three years;
- for a household \$50 per annum or \$120 for three years; and
- for organisations \$50 per annum or \$120 for three years.
