#### ANNUAL REPORT

The annual report for the 2020/21 year was presented as a website which can be found here.

lan spoke to the annual report highlighting key successes over the year.

## FINANCIAL RESULTS

The audited financial results for 2020/2021 were presented for approval.

Ian spoke to the financial results, noting that at the 2020 AGM the Board had tabled a budget for the year ending 30 March 2021 that would realise an approximate \$5k deficit. The actual result was a surplus of \$30,373. It was noted that this was well above the small loss forecast and a strong result after the challenges of a COVID-19 year. The overall cash position had improved by \$28,000 over the financial year.

It was explained that more subscription income had been received than budgeted for as we continued to grow our membership, reflecting the value we brought to our members over the last year. It was noted the auditor had given a clear and unqualified audit report and commended ACE New Zealand on our prudent financial management of the organisation.

## THE YEAR AHEAD

Helen provided an overview of the year ahead, and ACE New Zealand's forward work plan. The following points were highlighted:

- Over the last two years we have been working to a strategy focussed on raising our profile and brand, building trusting and influential relationships and modernising our technology to connect better with members. This has created a strong basis for ACE New Zealand to hone its resources now to where it delivers most relevance for members.
- To do this over the coming year, we would be carrying out research with our members to understand our
  value, and using that to define a new strategy for the next step in our evolution. Key opportunities include in
  relation to consultancy development training, cultural competency, supporting our members to manage
  wellbeing in the workplace, the Diversity Agenda, and developing a strong understanding of what ACE New
  Zealand membership stands for and how we operationalise that through a review of our Rules.
- Members can expect to see continued advocacy in regards to liability and risk, ensuring better contractual settings, and on the skills shortage.

lan spoke to the Board's confidence in the organisation and the year ahead, and thanked the ACE New Zealand team.

Ian signalled a raise in membership fees of up to 5 per cent for the next financial year. He noted that the raise is critical for ACE New Zealand to keep up with inflation and the additional costs that come with delivering our core work, while allowing us to take on some additional programmes of work that will offer a step-change in how we support members and set the organisation up for the future.

lan noted that the raise will take affect for the 2022/23 year, at which point it will have been close to three years since the last fee raise, and only the second raise since 2014.

# PRESENTATION OF THE 2021/2022 BUDGET

lan provided a high-level overview of the 2021/2022 budget and key areas of investment, including training and development, personnel costs, advocacy, and the Diversity Agenda.

lan noted that, to deliver our core work and realise our need to invest in our business and forward work programme, and recognising the welcome surplus achieved over the previous financial year, the Board decided to take a two-year breakeven view of our finances. This means that the Board approved a deficit of \$23,453 for the 2022 year, with the intention that we would achieve a break-even result over the two years (the 2021 and 2022 years) combined.
