6 ANNUAL REPORT

The Annual Report for the 2023/2024 year was presented and can be found here.

Ceinwen highlighted key outcomes for the 2023/2024 year, including:

- Increase the influence of the organisation through the transition to new Government,
- The new resources, events and networking opportunities we have provided for small and medium sized businesses,
- The collaborative work with other industry bodies and partners in particular Infrastructure New Zealand, Civil Contractors New Zealand, Master Builders and Water New Zealand,
- Our amplified voice through media engagement,



- Our volunteers review of NZS3910, all of Government CCCS Special Conditions, the Engineering Design Standards for Three Waters, the review of the Temporary Traffic Management Credentials Framework Governance Group, the TTM Industry Steering Group, the Waka Kotahi Road Workers Safety Governance Group, the Industry Steering Group for the HERA-led research project 'Low carbon design for a changing environment' and the Management Committee for the Society of Construction Contract Practitioners,
- The establishment of the Practice Managers Forum,
- Our inaugural SME Summit,
- The launch of Mindspace,
- The rebrand of our conference to Futurespace,
- All the alerts on onerous terms and conditions in pre-conditions and contracts, and

7 FINANCIAL RESULTS

The audited financial results for the 2023/2024 year were presented for approval.

Ceinwen spoke to the financial results, noting that at the 2023 AGM the Board had tabled a budget for the year ending 31 March 2024 that would realise a small surplus of \$10,056. The audited result was a surplus of \$142,942. We made an unbudgeted surplus of \$128,831 due to an increase in members leading to an increase in membership fees, favourable investment returns and prudent financial management.

Ceinwen noted that the unbudgeted surplus generates an opportunity for the Board to invest in ACE and our members over what is proving to be a tough environment. This includes building some limited reserves for ACE which has not kept pace with our organisations growth.

It was noted that the ACE auditor, Moore Markhams, had given a clear and unqualified report.

8 THE YEAR AHEAD

Helen provided an overview of the year ahead, continuing to embed the ACE strategic objectives and strong core services to ACE's members. The following areas of focus were highlighted:

- Continuing our work inputting into the review of the Special Conditions for the All of Government CCCS,
- Promotion of our Contract Checklist, enabling members to identify terms of concern,
- Events to support members,
- Engagement with Government ministers on key issues,
- Working with Waihanga Ara Rau (the Construction and Infrastructure Workforce Development Council) and Engineering New Zealand on a piece of research to understand the issues in the engineering workforce,
- ACE Awards, including our review of the awards,
- Guidance documents,
- A masterclass before our Futurespace conference with Maureen Thurston on unlocking the power in procurement,
- The Diversity Agenda support,
- Mindspace,



- The Pillars Competency Framework, identifying the most critical non-technical skills and competencies required to thrive as a professional service consultant, and
- Our conference Futurespace in Ōtautahi Christchurch,
- Our annual remuneration survey, and
- A new annual survey a business insights report.

9 PRESENTATION OF THE 2024/2025 BUDGET

Ceinwen provided a high-level overview of the 2024/2025 budget, which is working to a surplus of approximately \$16,000 for the year end 31 March 2024.

The budget forecasts conservative membership growth and other revenue from awards, conference, events, training and cost recovery. This year we are also implementing a new preferred support programme Budgeted expenditure is based on careful decisions on our priority investments in line with our strategy and aspirations for ACE, including investment in our people and organisation, annual activities (such as FIDIC, the Remuneration Survey and the Diversity Agenda and the introduction of a Business Insights Report). We have also allocated budget to Mindspace, and the continued development of the competency framework in the form of a digital tool, and our continued investment in our annual conference and awards along with a progressive procurement training opportunity.
