Prospective candidates and nominators should verify their financial status and any other qualifications required by the Union's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 5:00pm Australian Eastern Daylight Time (AEDT – Sydney Time) on 21 February 2019.

**PLEASE NOTE:**

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call 02 9375 6362 to enquire about the status of your nomination.

**Withdrawing Nominations**

A candidate who has been nominated in an election may, by notice in writing addressed to the Returning Officer, withdraw the nomination at any time before the printing of the ballot papers.

**Voting Period**

The ballot, if required, will open on 1 April 2019 and close at 12:00pm (noon) Australian Eastern Standard Time (AEST) on 29 April 2019.

**Scrutineers**

Candidates shall, before the closing of nominations, notify the Returning Officer in writing of the name of scrutineer(s). The appointment of scrutineers closes 5:00pm Australian Eastern Daylight Time (AEDT – Sydney Time) on 21 February 2019.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
