Councillor Saxe on the Case


Well <u>we</u> might have been out of town this past May, but that doesn't mean things weren't hopping in the 'hood, so to speak. In particular, Councillor Dianne Saxe was hard at work promoting Annex interests.

Taming Avenue Road

On May 10, City Council adopted <u>Councillor Saxe's motion</u> seeking to tame Avenue Road. The substance of the initiative was neatly summarized by our RARA neighbours to the north (<u>The Rathnelly Area Resident's Association</u>):

- 1. Reduce the speed limit between Bloor Street and St. Clair Avenue to 40 kilometres per hour from 50 km/h.
- 2. Request the Toronto Police Service to consider "enhanced speed enforcement ... because of the prevalence of illegal speeding and the resulting risk to pedestrian safety."
- 3. Install physical barriers in the curb lane in front of the Church of the Messiah to protect people using the day care and food bank.
- 4. Direct the Transportation Services department to report on a muchdelayed study on a redesign of the thoroughfare and to provide options for improving pedestrian safety by next July.

5. Direct Transportation Services to establish a pilot program to improve pedestrian safety by a variety of measures, such as sidewalk widening.



As the image above mutely testifies, something clearly has to be done to promote pedestrian safety! But while the motion is a vindication of the efforts of the <u>Avenue Road Safety Coalition</u>, it's just a start. We're counting on Councillor Saxe to keep Transportation Services' metaphorical feet to the fire on this one.

In the Name of Fitness

City Council's agenda for the daunting three-day marathon that began May 10 also included Councillor Saxe's revised motion regarding the expenditure of money on adult fitness equipment for Jean Sibelius Park. Specifically, she has recommended the enhancement of park facilities with an adult-sized balance beam, step benches, a group fit structure, and an exercise bench.



The revised motion addresses a convoluted set of financial transactions that must take place across various City accounts and budgets, roadblocks that thankfully didn't deter our Councillor. Decking out Dupont Station

Also on our Councillor's radar -- the current state of the Dupont subway station.

Six years ago -- virtually to the day -- a <u>Blog TO article</u> celebrating the best TTC subway stations rated Dupont number one. To quote the full citation: *Opened in 1978, Dupont is a perennial favourite of TTC riders for its mosaic tiles, dome entrances, and built-in benches. The attention to detail here is far greater than at*

the vast majority of stations on the line, for which kudos should go to Dunlop-Farrow Architects.

Alas, as any passerby can tell you, the exterior of the station fails to live up to its top billing. It began with good intentions as revealed <u>two years ago in this</u> <u>newsletter</u>. But a collage of photos assembled from Google by our P+D Co-Chairs – Elizabeth Sisam and Henry Wiercinski – highlights the sorry state of affairs today.



The pair wrote to Councillor Saxe arguing that funds available from the new development proposed at 374-390 Dupont should be directed towards at-grade improvements. To quote from their message:

... this development is located 270 metres to the west of two of the most unfriendly and inhospitable subway entrances on the system. There is only hard space, extremely limited and horrible seating. Yet this is the higher order transit consultants so enthusiastically reference when making the case for development projects.

It would be a true public service to the local community to direct funding to the northwest and southeast subway entrances for at-grade improvements including

benches, planting, lighting for safety, and waste containers.

In total agreement, Councillor Saxe has begun negotiations with the developer and on May 24 successfully sponsored a motion at TEYCC (Toronto East York City Council) arguing for the deployment of funds for the repair and enhancement of the station exterior. We'll keep you updated as this motion winds its way through the labyrinthian corridors of City Hall.


A Jane's Walk that Bears Repeating

On May 7 writer Katherine Govier led a *Jane's Walk* that brought to life the memorable opening of her magical collection of short stories entitled *Fables of Brunswick Avenue*:

Everyone lives on Brunswick Avenue sooner or later... Some longer than most. If you've never actually found the apartment of your dreams on this downtown street where anything is possible, then you may do so yet.

Govier actually lived at several addresses on the street, but *Fables* was written in an upstairs flat at number 411.



More than thirty participants followed Govier on her engaging walk despite the challenge of a very heavy spring rain. Former literary neighbours Susan Swan and Karen Mulhallen were also present to add their own anecdotes.

A charming recitation of *Alligator Pie* preceded the last stop of the tour at Jean Sibelius Square Park. However, on that grey, wet day, Dennis Lee's reflections on the park from his Governor General's Award-winning *Civil Elegies* came even more to mind. By the end of the walk, one was left wondering who didn't live and write on Brunswick?
