



# Why Australia needs **strong nature laws**

**Australia has one of the worst extinction records on Earth. Our current environment laws are failing to protect our iconic animals and the forests, rivers and wetlands we love.**

A once-in-a-decade review has recommended a complete overhaul of Australia's national environment laws and an independent regulator to enforce them. This is our chance to restore ecosystems and bring our wildlife back from the brink.

Australians agree and 505,872 people, including 108,104 from Victoria and 2,356 from your electorate of Chisholm, have signed ACF's petition demanding strong national laws that actually protect nature.

# Why Victoria needs strong federal nature laws

**Victoria's Mountain Ash forests and subalpine forests have been identified by scientists as "collapsing" ecosystems, meaning they have undergone such substantial negative changes they may not recover.**

The very animal symbols of Victoria - the Leadbeater's Possum (faunal emblem) and the Helmeted Honeyeater (bird emblem) are both listed as **Critically Endangered species**. These animals are irreplaceable, they are only found here in Victoria.

Habitat destruction impacts more threatened species than any other pressure, yet here in Victoria, habitat continues to be bulldozed at an alarming rate. The state-owned logging company VicForests has been found in a court of law to have breached state logging regulations by destroying habitat for two threatened species - the Greater Glider, listed as Vulnerable, and the state's own Critically Endangered animal emblem, the Leadbeater's Possum. Despite bulldozing critical threatened species habitat, this logging is exempt from federal environment law. Do Victoria's iconic threatened species even stand a chance under current environmental laws?

**We need strong federal laws that actually protect Victoria's plants, animals and ecosystems.**
