RIGHT-OF-WAY

#### Section A

1. There is hereby granted, pursuant to Title V of the Federal Land Policy and Management Act of 1976 (43 U.S.C. 176), a nonexclusive, nonpossessory right-of-way to:

- 2. To use, subject to terms and conditions set out below; the described lands attached hereto as Exhibit "A":
- 3. Description of the right-of-way facility and purpose:

The right-of-way is for County roads previously authorized under R.S. 2477 and other unauthorized and recognized roads existing on public land prior to Ocotber 21, 1976. The right-of-way is 60 feet wide and 33.75 miles in length, and contains 245.45 acres more or less.

A map showing the locations of the right-of-way over the above described public land is designated Grant County Road Map, dated 1980, and is made a part of the case file.

#### TERMS AND CONDITIONS

#### Section B

- 1. The right-of-way holder agrees to comply with all the applicable regulations contained in 43 CFR 2800.
- 2. If the right-of-way holder violates any of the terms and conditions to this grant, the authorized officer, after giving written notice may declare the grant terminated.

#### EXHIBIT "B"

- The holder shall provide maintenance so that the road will be in a condition equal to the normally prevailing condition on roads of like standard.
- No new county roads will be accepted as amendments to this grant.
   A separate application must be filed for each new county road needed in the future.
- 3. Future requests to either amend or partially relinquish portions of the county roads approved under this right-of-way grant will be processed under serial number NM 52981.
- 4. The width of the right-of-way will be 60 feet.

- 3. This grant is subject to all valid rights existing on the effective date of this grant.
- 4. There is reserved to the authorized officer, the right to grant additional rights-of-way or permits for compatible use on, over, under or adjacent to the land involved in this grant.
- 5. The right-of-way shall be relinquished to the United States if the authorized use is no longer needed.
- 6. All other terms and conditions. Compliance will be in accordance with the terms and conditions as specified herein and in Exhibit "B", attached hereto and made a part hereof.
- 7. Rental. None.
- 8. This right-of-way grant is perpetual, unless it is relinquished, abandoned, terminated, or otherwise modified pursuant to the terms and conditions of this grant or of any applicable Federal law or regulation.

Section C

The effective date of this right-of-way grant is the date of execution by the authorized officer.
