KIRTLAND BACKCOUNTRY HUNTERS & ANGLERS IS CHARTERED WITH THE BASE SAFETY OFFICE. ANY INFRACTION OF THE RULES WILL CAUSE THE BASE TO REVIEW OUR PROCEDURES TO ENSURE ENFORCEMENT OF OUR ESTABLISHED GUIDELINES. THESE RULES MAKE THE RANGE A SAFE PLACE TO ENJOY ARCHERY.

RANGE FEES

ALWAYS CARRY YOUR RANGE FEE PAYMENT CONFIRMATION ON YOUR PERSON WHILE USING THE RANGE. IF SOMEONE ELSE IS ON THE RANGE, ASK TO SEE THEIR MEMBERSHIP CONFIRMATION. IF THEY ARE NOT A MEMBER, OR THEIR MEMBERSHIP IS EXPIRED, REFER THEM TO THE QR CODE ON THE BULLETIN BOARD. ALWAYS BE COURTEOUS IN YOUR APPROACH.

BROADHEADS AND CROSS BOWS

CROSSBOWS ARE NOT PERMITTED ANYWHERE ON RANGE PROPERTY.
BROADHEADS ARE ONLY PERMITTED IF YOU HAVE YOUR OWN TARGET AND WE
ASK THAT YOU DO NOT SHOOT BROADHEADS INTO THE BALES OR USE THE
BALES AS THE BACKSTOP FOR YOUR BROADHEAD TARGETS.

GUESTS

GUESTS ARE ALWAYS WELCOME, BUT DON'T LET YOUR INDIVIDUAL MEMBERSHIP BECOME A MEMBERSHIP FOR TWO. YOU MUST SCAN THE QR CODE TO PAY GUEST RANGE FEES AND SIGN THE LIABILITY FORM. MEMBERS THAT ARE ACCOMPANIED BY A NON-MEMBER SHOOTER MAY FACE MEMBERSHIP REVOCATION.

DRUGS & ALCOHOL

DRUGS AND ALCOHOL ARE NEVER PERMITTED ON ARCHERY RANGE PROPERTY.

RANGE MAINTENANCE

CLUB MEMBERS PERFORM ALL MAINTENANCE. WORKING MEMBERS PAY A REDUCED RANGE FEE AND ARE REQUIRED TO PARTICIPATE IN TWO RANGE IMPROVEMENT DAYS PER YEAR. PERIODIC WORK DAYS MAY BE SCHEDULED FOR SPECIAL PROJECTS OR GENERAL MAINTENANCE AS WE IMPROVE THE RANGE. IF YOU ARE SCHEDULED FOR A WORK PARTY, PLEASE SHOW UP.
