Your bargaining committee met with the Employer on April 12<sup>th</sup> and 13<sup>th</sup> and again May 10<sup>th</sup> and 11<sup>th</sup>. In April both parties tabled their non-monetary packages. We have made excellent progress with agreement reached on many proposals for common language which will apply to all collective agreements.

We have additional dates scheduled for May 24<sup>th</sup> & 25<sup>th</sup> and June 13<sup>th</sup> & 14<sup>th</sup> at which time we will continue to work on all outstanding non-monetary issues.
