DEMOCRATS AND MARIJUANA

A Wall Street Journal/NBC poll reported in January 2014 that 55 % of Americans want marijuana to be taxed and regulated like alcohol and tobacco. Gallup, Pew, Rasmussen and other polling organizations have reported similar results.

Yet, this is an issue of immense importance. American taxpayers fork over \$20 billion every year entangling over 850,000 Americans in the criminal justice system. There are tens of thousands of murders taking place along our border with Mexico and much of it has to do with smuggling marijuana into this country. What other issue impacts so many Americans at such a staggering cost in dollars and lives and is so completely sidelined by not only timid politicians, but a complacent media?




As for health concerns – pain relief, depression mitigated, a truly good night's sleep, a substitute for alcohol – cannabis has been used for over 5,000 years safely and effectively. With up to 1/3 of our returning vets from Iraq and Afghanistan

suffering with PTSD, cannabis offers the safest and most effective treatment without any of the deleterious side effects associated with the prescription pharmaceuticals so liberally dispensed at every VA facility.

In May 2012 a bill that would greatly benefit medical marijuana patients passed the California State Assembly 41 to 28. Every vote in favor was cast by a Democrat – not one Republican supported medical marijuana patients. Also in May, in a vote to defund the Department of Justice from conducting raids against medical marijuana providers, 72% of the Democrats in the House of Representatives voted to stop the raids. Only 11% of the Republicans voted to stop the raids.

Democrats support marijuana law reform and the club has been formed to work within the Democratic Party to encourage and support Democrats who nurture marijuana policy reform based on compassion and common sense.

- **3.** Would improve U.S. foreign policy in Latin America and other countries where Washington's drug war has long strained diplomatic relations.
- **4.** Eliminate a major source of funding for criminal gangs and terrorist organizations.
- **5.** Provide a significant new source of revenue for schools, health care and other government services.
- **6.** Provide a safer alternative to alcohol for relaxation, socialization and celebrations.
- **7.** Create tens of thousands, if not hundreds of thousands, of new well-paying union jobs as is being developed and supported by the United Food and Commercial Workers union
- **8.** Allow a new valuable crop for American farmers for the production of hemp for fiber, food, fuel and many other commercial and industrial uses.
- **9.** Marijuana is not a gateway drug, has a low risk of abuse and no one has ever died from an overdose or any disease associated with its use.
- **10.** Reestablish its documented 5,000 year use as a medicine to relieve pain, fight cancer, facilitate sleep, slow aging, mitigate movement disorders, modulate auto-immune inflammatory diseases and provide safe therapeutic relief for a host of other disabling ailments.
