Meeting started at 6 pm:

Supervisor Matt Dorsey mentioned there is a January 6 capitol insurrection hearing today. He is on the job for one month and appointed by Mayor Breed. It is a personal journey that started when working under Arlo Smith many years ago. He cares about the drug addiction recovery programs, SF, Covid 19, automobile break-in, 911 issues, police, SFPD, public safety, hate crimes, housing, bilateral language information, public transportation, education, city college, city hospitals, and environmental issues.

SF City District Attorney gave a presentation on his job. The areas covered in his job are located in the internet. His office counsel all city officials and departments, including airport, water, police, fire, zoo, etc. They write all city contracts and perform litigations. Their focus included corruption, pollution, housing, homelessness, hold pharmacy manufacturers for the overdose, drug dealer injunction, Roe vs Wade issues, and all legal matters. They also work with outside attorneys to prepare lawsuits. The office is not allowed to endorse any officials, candidates, propositions, etc. After the city prosecutor recalled, the city should move forward. This city is progressive but also need to care for safety. There should be some balance. The office is not familiar with MediCal or MediCare services. The city does go after slumlords and will answer in court on the Mission Bay sinking sidewalk issues. The office will address the fossil

Concealed weapon in SF is not allowed. Wealth test for immigration created by President Trump has been overturned but may continue to argue.
