(10) Proposal to revise CC Protocol on General Assembly guests

**Sponsor:** Laura Wells

**Background and Purpose:** The history of non-party guests at state General Assemblies (GAs) is that per the Bylaws guests were welcome before 2013. In 2013 the GPCA Bylaws and many committee rules were re-organized and in many cases re-written. The policy about GA guests was moved from the Bylaws to the Coordinating Committee (CC) Protocol, and guests were restricted to those invited by the CC. Due to the difficulty of getting a CC decision as fast as needed for GA planning and scheduling, what

resulted was that before every GA, the GA Planning Team tried to remember to request the ability to invite non-party guests, and the CC always approved the request. This proposal to change the CC Protocol will make it unnecessary for the planning team to remember to request that exception before each and every GA.

**Proposal:** The existing language is below, with the proposed change in the second paragraph in ALL CAPS, i.e. adding "by the General Assembly Planning Team, or by General Assembly session sponsors or presenters,".

### **Article VIII. GPCA General Assemblies and Gatherings**

8-1 Attendance at GPCA General Assemblies

GPCA General Assemblies shall be open to County Delegates, Party Officers, members of the Coordinating Committee, Coordinators of Standing Committees and Working Groups. Space-permitting, all other members of the Green Party of California are also able to attend.

The only non-party individuals who may attend shall be those invited by the Coordinating Committee, BY THE GENERAL ASSEMBLY PLANNING TEAM, OR BY GENERAL ASSEMBLY SESSION SPONSORS OR PRESENTERS, either at its their own initiative or at the recommendation of other party committees, working groups or county party organizations, for purposes pertinent to the business of the GPCA.

(And we'll also be assisting the candidates with various other campaign tasks over the coming several months).

- (1) We are still working on a "Needs Assessment", which will list various "needs" for the GPCA to undertake in order to have the best campaign possible for our statewide candidates. However, our top priority right now is to get the signature-gathering campaign "up and running", etc.
- (2) As we have been, we are planning to continue meeting every other week, on Thursday evenings
- (3) We will be staying in touch with the Peace and Freedom Party about the statewide candidates campaign, and we'll meet with them (on Zoom) as needed.
