(7) Decision Item: Subject: Schedule next GPCA General Assembly, weekend of July 9-10, 2022 (10 minutes)

Sponsor(s): Mica Daniel (Alameda County)

Background and Purpose:

At the December 2021 General Assembly, a variety of possible dates for the next GA were discussed by the attendees but no firm date was picked, which means the CC needs to pick a weekend for the next State gathering. Given the utility, affordability, and climate benefits of meeting via Zoom rather than in-person, the CC should make a decision to hold the next GA via Zoom. And, because we switched our fiscal year from a July 1 to June 30 fiscal year to a calendar fiscal year, we don't need to bind ourselves to a May or June GA date.

This year, we have elections in California on June 7, 2022, Gay Pride weekend in Los Angeles from June 10 to June 12, Father's Day on June 19, and Gay Pride weekend in San Francisco from June 25 to

June 26. Scheduling a full weekend for a GA in a month already chock full of events may not be the best strategy for maximizing attendance. In addition, If we wait until after the June 7 election, we may be able to schedule candidates to discuss their campaigns more easily in July than if we were to shoot for a GA in May or June.

We could also schedule a separate candidates forum via Zoom for some time prior to the upcoming SGA vote to have a Q&A with Statewide candidates, CC candidates, and GPUS Delegate and Alternate Delegate candidates. That decision could be fleshed out later and decided at the May 2022 CC meeting.

Proposal: We schedule the next GA via Zoom for the weekend of July 9-10, 2022.

Implementation/Timeline/Resources:

By approximately April 9, 2022, the CC should request that the Agenda Planning team send out an announcement of a July 9-10, 2022 General Assembly and include a request for GA Agenda items by no later than May 21 (6 weeks). The GPCA Bylaws require a draft agenda to be posted at least 42 days prior to the GA. 42 days prior to July 9, 2022 is May 28, 2022, which would give the Agenda Planning team one week to turn around a draft GA Agenda. The Agenda Planning team would need to be prepared to roll this out, and the proposed timeline would play out as follows:

Call for Agenda Items - April 9, 2022 (Saturday) Deadline for Agenda Items - May 21, 2022 (Saturday) Publish draft GA Agenda - May 28, 2022 (Saturday) Hold GA - July 9-10, 2022 (Saturday/Sunday)

# (9) Proposal: Discussion/Decision: Donate \$500. to Jill Stein 2016 Presidential Campaign (15 minutes)

Sponsor: Mica Daniel, Finance Committee

Background:

From Jill Stein, quote:

"Earlier this month, our legal team filed in the US Court of Appeals for the DC Circuit to appeal the FEC's decision demanding that our 2016 campaign repay over \$175,000 in public matching funds we spent on ballot access.

The FEC's decision threatens to stick me with a massive bill five years after the end of our campaign - but to make things even worse, the precedent would seriously discourage independents and alternative parties from using federal public matching funds to get on the ballot in elections to come. "We're fighting back because if the FEC's punitive decision is allowed to stand, it would be a massive deterrent to grassroots challengers at the top of the ticket that could also make it far more difficult for candidates to run in local 'down-ballot' races where Greens and other independents have had the most success.

"Our legal team's statement of issues to be raised on appeal - which you can see here - challenges the FEC's unjust decision on a number of fronts, from its timing five years after the election to the legal premise of the decision itself." [End quote]

It is our belief that this is all about ballot access, keeping third parties off the ballot, and also to eliminate matching funds.

I believe very strongly that an injury to one is an injury to all. I believe that as a State Green Party we need to step up with whatever help we can.
