#### **Candidates Committee report -- 1/31/23**

- 1. Members and volunteers -- The Candidates Committee is now in the process of actively being formed. A number of Greens have specifically been invited to join (including a handful earlier today) but thus far only one other person has expressed interest. By next month I expect we'll have our first meeting, even if we might have to start out with just a few of us.
- 2. Tasks -- For convenience, I think it might be helpful to categorize the different types of elections we'll be working on -- that is, for 2023 (and into next year), I see these 4 types of elections:
  - 1) Local "non-partisan" elections (such as City Council, School Board, Water District, etc.);
  - 2) "Partisan" elections for state legislature, and for the US House of Representatives;
  - 3) US Senate; and
  - 4) President.

Regarding the last category (President), although I'm pretty sure that the national Green Party will take the lead in identifying and "recognizing" Green Presidential candidates, we will review the process for selecting California's delegates to the national Green Party's Presidential Nominating Convention, as well as the process for placement of Green Presidential candidates onto the California Presidential primary ballot.
