#### Part 1 ...

Part I: That the GPCA-CC convene an SGA between Monday, September 11 through Sunday, October 15, with a vote between Monday, October 16 and Sunday, October 22.

Greg Jan stated that we do not have as many volunteers to work on an SGA, therefore it will be easier to do an online GA within the same time period. Oct 14-15 or Oct. 21-22 would be good dates. The GA planning Committee can decide. Charisse will forward it to Tarik. The GA could take the place of the GA previously scheduled for November. Laura expressed one concern that the budget needs to be done before the end of December...so is the later October date better?

#### Friendly Amendments Approved by consensus

**Part 2...** That the recommendations to the SGA for GPCA recommendations for placement on the GPCA's March 5, 2024 presidential primary ballot be automatically included on the SGA agenda, and that the SGA agenda be open to any other proposals submitted by GPCA committees and/or county parties, as would be the case for any other SGA via the regular proposal submission process

Greg notes that this part is straightforward. One additional item is that we cannot put out any promotional material about Cornel West until we endorse him. We can endorse him at the October GA and start the publicity process.

#### **Part 3...**

That the GPCA-CC approve the following bylaws interpretation and also place it on the September/October 2023 SGA agenda

Whereas GPCA Rules ARTICLE I. Presidential Primary Election Ballot 1-3.1 and 1.3.2 empower the GPCA Campaigns and Candidates Working Group to make recommendations to the GPCA regarding which candidates shall be considered by the GPCA for recommendation to the California Secretary of State for placement upon the GPCA's presidential primary ballot; and

Whereas the GPCA amended its bylaws in 2022 to eliminate the Campaigns and Candidates Working Group, but did not amend this text in GPCA Rules ARTICLE I. Presidential Primary Election Ballot; and

Whereas in order to meet legal deadlines set in the California Elections Code, the GPCA will need to convene an SGA in September/October 2023 to make its recommendations in a timely manner to the California Secretary of State; and

Whereas there is no time to amend GPCA Rules ARTICLE I. Presidential Primary Election Ballot before those recommendations are made; and any rules change made as part of that September/October 2023 SGA cannot retroactively apply to ARTICLE I. Presidential Primary Election Ballot,

Therefore the GPCA-CC approves a bylaws interpretation under GPCA Bylaw 12-3 (https://www.cagreens.org/bylaws-green-party-california#Section\_12-3. Bylaws Interpretation) that on a one-time basis applying to decisions taken during the September/October 2023 SGA regarding GPCA recommendations to the California Secretary of State regarding placement of candidates on the GPCA's March 5, 2024 presidential primary ballot, that the GPCA Candidates Committee (https://www.cagreens.org/bylaws-green-party-california#Section\_9-6. Candidates Committee) shall be empowered to make recommendations as specified for the Campaigns and Candidates Working Group in GPCA Rules ARTICLE I. Presidential Primary Election Ballot 1-3.1 and 1-3.2

Greg and Mimi felt that this part is a technicality That has already been addressed and that there is no need for a bylaws interpretation or for any action to be taken. This part should be removed from the proposal.

#### **Background:** Under California Elections Code 6851

(https://leginfo.legislature.ca.gov/faces/codes displaySection.xhtml?lawCode=ELEC&sectionN um=6851, https://www.cagreens.org/elections-code/presidential-primary-ballot), the California Secretary of State (SoS) "shall place the name of a candidate upon the Green Party presidential preference primary ballot when the Secretary of State has determined that the candidate is generally advocated for or recognized throughout the United States or California as actively seeking the presidential nomination of the Green Party or the national political party with which the Green Party is affiliated."

Under the California Elections Code 6851.5

(https://leginfo.legislature.ca.gov/faces/codes displaySection.xhtml?lawCode=ELEC&sectionN um=6851.5, https://www.cagreens.org/elections-code/presidential-primary-ballot ), the Green Party of California (GPCA) may make a recommendation to the California Secretary of State (SoS), regarding who the SoS shall place on the GPCA's ballot under California Elections Code 6851.

Between 1996 and 2012, the GPCA convened a General Assembly every four years to make that decision. Once the GPCA adopted the use of Standing General Assemblies (SGA) as a form of the General Assembly, the GPCA has used SGA's to vote on which candidates to recommend, starting in 2016 (http://sga.cagreens.org/vote/propdetail?pid=76,

http://sga.cagreens.org/vote/propdetail?pid=77,

http://sga.cagreens.org/vote/propdetail?pid=78,

http://sga.cagreens.org/vote/propdetail?pid=79).

This is a proposal for the GPCA State Coordinating Committee (GPCA-CC) to convene an SGA in 2023 for this purpose.

## What should the timing be for this SGA?

As per GPCA Rules and Procedures ARTICLE I. Presidential Primary Election Ballot (<a href="http://cagreens.org/rules#Article">http://cagreens.org/rules#Article</a> I. Presidential Primary Election Ballot), the GPCA's recommendation to the SoS must be made between E-125 and E-190. Counting back from the March 5, 2024 California primary, subtracting 125 days would mean the GPCA would need to communicate its decision by no later than October 31, 2023. Subtracting 190 days would mean the GPCA would need to communicate its decision no earlier than August 27.

Since an SGA requires a six-week discussion period and one week vote, and because an SGA ends on a Sunday, the GPCA's decision would need to occur by the last Sunday before October 31 or no later than the last Sunday before August 27. With this in mind, the latest the SGA could run with a discussion between Monday, September 11 and Sunday, October 22, with a vote between Monday, October 23 and Sunday, October 29. The earliest would be with a discussion between Monday, July 10 and Sunday, August 20, with a vote between Monday, August 21 and Sunday, August 27.

In order to give the most time for potential 2024 candidates to communicate to the GPCA, the SGA should be held towards the latter end of this time period. But to ensure that there is a buffer in case something unexpected occurs, it would be prudent for the GPCA to not wait until the last possible week to make its decision, but instead conduct an SGA to end one week earlier. That suggests an SGA with a discussion from Monday, September 11 through Sunday, October 15, with a vote between Monday, October 16 and Sunday, October 22.

The process for applying to the GPCA and how recommendations are placed before the SGA is described in GPCA Rules and Procedures ARTICLE I. Presidential Primary Election Ballot (<a href="http://cagreens.org/rules#Article\_I.">http://cagreens.org/rules#Article\_I.</a> Presidential Primary Election Ballot). The latter process involves recommendations by either/and the GPUS Delegation to the GPUS and the GPCA Campaigns and Candidates Working Group.

However, when the GPCA eliminated the Campaigns and Candidates Working Group in July 2022, it failed to consider this text and left it as is. Therefore, for the purposes of expediting the recommendation process in 2023, this proposal includes the GPCA-CC approving a bylaws interpretation under GPCA Bylaws 12-3 (<a href="https://www.cagreens.org/bylaws-green-party-california#Section 12-3. Bylaws Interpretation">https://www.cagreens.org/bylaws-green-party-california#Section 12-3. Bylaws Interpretation</a>), that for the one-time purposes of the Fall 2023 SGA, the GPCA Candidates Committee shall be empowered to make recommendations as previously provided for by the Campaigns and Candidates Working Group. That bylaws interpretation would be placed before the same September/October 2023 SGA for approval.

If the GPCA Bylaws Committee, a county party or the GPCA-CC wanted to put forward a proposal to make a change in ARTICLE I. Presidential Primary Election Ballot, it could do so by submitting a proposal to also be considered by the September/October 2023 SGA.

Under ARTICLE I. Presidential Primary Election Ballot 1-3.1 (<a href="http://cagreens.org/rules#Section">http://cagreens.org/rules#Section</a> 1-3 Written Requests), the timing for candidates to submit their applications is no later than one week before the SGA would commence

1-3.2 Be submitted at least seven days before the General Assembly (or meeting of the Coordinating Committee) but preferably earlier with the knowledge of the dates when the GPUS Delegation and/or the Campaigns and Candidates Working Group will meet to make recommendations under 1-4.1. The dates of those meetings shall be made available to the co-

chairs GPUS Presidential Campaign Support Committee for distribution to those who have contacted the GPUS to seek its presidential nomination.

If the September/October 2023 SGA were to begin on Monday, September 4, then the deadline to be considered would be Monday, August 28 - and the GPUS Delegation and the GPCA Candidates Committees should both plan meetings to consider its recommendations in time to forward to the GPCA-CC so that it may place them before the SGA starting on September 4. These dates should be published on the GPCA website and communicated to the Green Party of the United States (GPUS) Presidential Campaign Support Committee (PCSC), as provided for in 1-3.2 above.

#### **PROPOSAL:**

Part I: That the GPCA-CC convene an SGA between Monday, September 11 through Sunday, October 15, with a vote between Monday, October 16 and Sunday, October 22. Part II: That the recommendations to the SGA for GPCA recommendations for placement on the GPCA's March 5, 2024 presidential primary ballot be automatically included on the SGA agenda, and that the SGA agenda be open to any other proposals submitted by GPCA committees and/or county parties, as would be the case for any other SGA via the regular proposal submission process

Part III: That the GPCA-CC approve the following bylaws interpretation and also place it on the September/October 2023 SGA agenda

Whereas GPCA Rules ARTICLE I. Presidential Primary Election Ballot 1-3.1 and 1.3.2 empower the GPCA Campaigns and Candidates Working Group to make recommendations to the GPCA regarding which candidates shall be considered by the GPCA for recommendation to the California Secretary of State for placement upon the GPCA's presidential primary ballot; and

Whereas the GPCA amended its bylaws in 2022 to eliminate the Campaigns and Candidates Working Group, but did not amend this text in GPCA Rules ARTICLE I. Presidential Primary Election Ballot; and

Whereas in order to meet legal deadlines set in the California Elections Code, the GPCA will need to convene an SGA in September/October 2023 to make its recommendations in a timely manner to the California Secretary of State; and

Whereas there is no time to amend GPCA Rules ARTICLE I. Presidential Primary Election Ballot before those recommendations are made; and any rules change made as part of that September/October 2023 SGA cannot retroactively apply to ARTICLE I. Presidential Primary Election Ballot,

Therefore the GPCA-CC approves a bylaws interpretation under GPCA Bylaw 12-3 (<a href="https://www.cagreens.org/bylaws-green-party-california#Section\_12-3.">https://www.cagreens.org/bylaws-green-party-california#Section\_12-3.</a> Bylaws Interpretation) that on a one-time basis applying to decisions taken during the September/October 2023 SGA regarding GPCA recommendations to the California Secretary of State regarding placement of candidates on the GPCA's March 5, 2024 presidential primary ballot, that the GPCA Candidates Committee (<a href="https://www.cagreens.org/bylaws-green-party-california#Section\_9-6.">https://www.cagreens.org/bylaws-green-party-california#Section\_9-6.</a> Candidates Committee) shall be empowered to make recommendations as specified for the Campaigns and Candidates Working Group in GPCA Rules ARTICLE I. Presidential Primary Election Ballot 1-3.1 and 1-3.2

Part IV: That the GPCA-CC send out notification of the dates of the September/October 2023 SGA to the county parties and other Greens via the GPCA's Inform list and other regular means of communication, that it includes a deadline for county parties to send in their new SGA delegates to ensure full participation in the September/October 2023 SGA and that it includes contact information and deadlines for any other proposals that county parties and/or GPCA committees want to submit for consideration by the September/October 2023 SGA.

Part V: That the GPCA notify the Presidential Campaign Support Committee of the Green Party of the United States of the dates of the September/October 2023 SGA and of meetings by the GPUS Delegation and the GPCA Candidates Committee and that this information be published on the GPCA website and shared via GPCA official social media.
