## Mimi Newton appointment to the Finance Committee

**Preface:** In its May 2025 Report, the Finance Committee notified the CC that "The Finance Committee needs members, as we are not currently a functional committee per requirements set forth the Bylaws. We do not have a liaison to the CC. Justin (Treasurer and ex-officio member) has been creating agendas, facilitating meetings, and preparing minutes for the CC for the past 9-12 months. We have no 'members' presently and cannot carry out our duties per the Bylaws." I attended the subsequent Finance Committee meeting after the CC's receipt of this report. However, I was unable to attend the most recent June Finance Committee meeting, due to a conflict. I would like to join the Finance Committee at this time and am submitting the application below for your consideration.

## **Application:**

I'm a resident of Fairfax, California and a Member of the Marin Greens County Council. I'm currently on both the GPCA Coordinating Committee and the Bylaws and Rules Committee. I have been continuously registered as a Green Party member since attending law school in the late 80's.

After moving to Southern California in the mid 90's and then to Northern California in 2000, I've been an active Green at the local level since about 2006.

Upon initially attending GPCA General Assemblies, I began attending Finance and Fundraising meetings in about 2016. However, shortly thereafter, in 2017, I realized Federal employee ethics rules prohibit participation in political party fundraising, and I stopped attending those meetings.

After my recent retirement from the US EPA, I am no longer prohibited from participation in the Party's fundraising efforts. I'd like to be appointed to the Finance Committee so that I can assist the Treasurer and the rest of the Finance Committee where possible. As a member of the GPCA Finance Committee, I would be happy to help the Party with its financial accounting, budgeting, fundraising and other work.

**Background and Purpose:** There were no electronic formal alerts for submission of items received by the PPC CoCo for the June 14 2025 General Assembly. Apparently, the submission deadline was April 18 2025 sent on March 14 2025 on the Inform List (I am not on that listsery or the CC's) when the exact date of the General Assembly was unknown. In the past, a reminder

e mail was sent about a week before the deadline, but I never received that. I also did not receive an e mail announcing the draft agenda that should have been received by about May 2 2025.

The GPCA Bylaws have the following crucial time for GAs and SGAs:

7-5.1 Draft Agenda

The Coordinating Committee shall establish a Draft Agenda for all General Assembly meetings, distribute it at least 42 days in advance to each County Organization and submit it for approval at the beginning of each General Assembly.

There is no language for the timelines for the initial notification and the reminder, the last being the most critical.

The PPC suggests the following revision (new=underlined; struck out=deleted)

7-5.1 Draft Agenda

The Coordinating Committee shall establish a Draft Agenda for all General Assembly meetings, distribute it at least 42 days in advance to each County Organization <u>and Committee</u>

<u>Coordinators</u>, and submit it for approval at the beginning of each General Assembly. <u>A reminder message shall be distributed a week ahead of the submission date indicated on the initial notification</u>.

#### (8) PROPOSAL: Request to Butch Ware regarding posting

**Subject/Title:** GPCA-CC request to Butch Ware regarding his posting about ICE rallies and Palestine

**Co-sponsors:** Greg Jan and Laura Wells, and those who responded to Greg's call for a special meeting on this issue: Ashley Brown, Charisse Cordero, Richard Gomez, Susan Lamont, Don Manro, and John Schmit

**Background and Purpose:** On June 8, Green candidate for governor Butch Ware wrote a post on Instagram about the planned participation or non-participation by American Freedmen in the June 14 anti-ICE rallies. The text of the post is included in the draft email in **Appendix L** and as a link in the References section. In response to the Instagram post and other communications, Audra Walton submitted a resignation letter to the CC on June 25 (see References). On July 1, Greg Jan asked for volunteers to discuss the issue at a special meeting, which happened on July 7 at 9:30 AM, the morning of this monthly CC meeting. It was attended by the eight CC members listed as co-sponsors of this agenda item.

**Proposal:** That the GPCA-CC send an email to Butch Ware, with a CC to the Butch Ware for Governor campaign manager Jason Call, asking for an apology for his choice of words, and a statement with more information about his point of view. See **Appendix L** for draft email.

**Implementation/Timeline/Resources:** Timing would be within days. The sending email address of the request needs to be determined, as well as the list of contacts for questions.

## **MINUTES 5/29/25**

Shane reported on the abortive attempt to have 3 Platform planks (Human Rights and Civil Liberties; Affirmative Action; on the agenda of the June 14 GPCA GA.

Eric reported on his recently changed SB254 opposition draft for CC vote that Don will present at the next CC meeting. The draft deletes the other bills that might be also opposed. Eric will send the below final draft to the PPC listsery.

## **Proposal**

Subject/Title: POLICY - GPCA Opposition to SB 254 (utilities-wildfire-renewables)

Co-sponsors: Don Manro, Eric Brooks

Background and Purpose: For the GPCA to oppose SB 254 in order to help prevent circumvention of the California Environmental Quality Act (CEQA) and prevent California general fund expenditures, to improperly benefit utility monopolies and large electrical energy users, resulting in the following problems.

SB 254 would:

- 1) Waive California Environmental Quality Act (CEQA) review for all transmission wire undergrounding projects!
- 2) Waive CEQA for individual clean energy projects by allowing the California Energy Commission (CEC) to create statewide umbrella Environmental Impact Reports (EIRs) for classes of clean energy projects! (For example, if the CEC created one of these statewide EIRs for the project class of large solar-thermal arrays, they could be approved without CEQA review regardless of where they were cited!)
- 3) Provide higher rebates for very low-income customers, but also allow the CPUC to more easily approve rate increases (point 4) potentially eliminating the increased rebates.
- 4) Allow the CPUC to even more easily approve rate increases to customers for wildfire mitigation projects.
- 5) IMPORTANT: SB 254 Would potentially reduce electricity rate increases for wildfire and clean energy project costs, but would do so by using state tax revenues to create a 'POWER' fund to cover customer bills while doing nothing to transfer any of these costs to the monopoly utilities like PG&E or their shareholders!

Proposal: That the GPCA establish formal opposition to SB 254 by a consensus call of the Coordinating Committee.

Implementation/Timeline/Resources:

Timeline: Urgent - SB 254 will be moving rapidly through the California Assembly beginning in early June.

Implementation: The Policy and Platform Committee will notify other GPCA committees, and others, of the position, and will take steps to communicate the GPCA's opposition to legislators - all using the text above.

Resources: These actions can all be done electronically through email and via online comment forms.

- 2. Don confirmed that SB 254 (utilities-wildfire-renewables) was officially opposed by GPCA by consensus. He was congratulated for his election to the CC.
- 3. Peggy was happy with the elected GPUS GPCA delegates.

## 4. Policy:

Eric notified that SB 607 and AB 306 have been morphed together to a new AB 130 in the Governor's Budget Trailer bill. SB 607 would eliminate in-depth environmental review for a long list of polluting development projects countermanding the California Environmental Quality Act. There needs to be no action by the CC at this stage. He would follow up with an updated post to the PPC listserv.

#### 5. Platform:

Charisse proposed that the draft Indigenous Reparations & Other Reparations and the draft Indigenous People & First Nations platforms be sent to her to be relayed to her son who has a degree in American Indian Law who has many tribal contacts for input. Eric said he would do that after the zoom meeting and also cc the voting PPC members. He also would contact Tony Gonzalez in San Francisco County and Don also had a contact with the Taichi tribe in Tulare County. Eric hoped to have a zoom with all interested representatives.

It concerns this Instagram post from @butchware.bsky.social on June 8, 2025 at 1:57 PM.

"Black folks that say of Palestine — or Los Angeles 'not our fight' are the worst treacherous backstabbing Uncle Ruckus coons

You sound dumb saying a fight against white supremacy isn't our fight.

We literally invented blackness from hundreds of African identities just to oppose white supremacy."

With respect for the tremendous undertaking of your running as a Green candidate for Governor of California, a critical state in these dangerous times, the Coordinating Committee is requesting that you offer an apology — of course in words that are true for you — for having used words that had the effect of disrespecting, offending, and otherwise hurting people who are choosing to struggle for a better world in the ways that they choose. The words you wrote had the effect of further dividing people rather than uniting them in support of what we're trying to do in the Green Party and in your campaign.

In the Green Party it's important that our Green activists and candidates understand that everyone has the right to make their own decisions about how they engage in the movement, and our job is to respect that.

We also believe it would be helpful and instructive, along with an apology that's true for you, to have a statement from you that can help people understand more fully your point of view behind that post, so that we can understand "where you are coming from" without being put off by those words that can so easily be taken as an extremely targeted, dehumanizing racial slur.
