ITEM REGARDING REAPPOINTMENT OF LIAISON TO CALIF. SOS's OFFICE

SPONSOR: Coordinating Committee

PRESENTER: Greg Jan, [Alameda County]/ Mimi Newton, Marin County

SUBJECT: Confirm Jared Laiti as Liaison to the Secretary of State

BACKGROUND AND PURPOSE: Back in June of 2023, at our General Assembly (GA) meeting then, we confirmed Jared Laiti as our Liaison to the Secretary of State. Our bylaws (in section 4-7) say that the term for that position is two years, and Jared has agreed to serve another term. Therefore, the Coordinating Committee, at its early April, 2025 meeting, re-nominated Jared to continue in this position (from June, 2025 to June, 2027), as he continues to do a great job.

PROPOSAL: That the Green Party of California, via its General Assembly meeting, re-appoint Jared Laiti to another term as our Liaison to the Secretary of State

COMMITTEE DECISION: The Coordinating Committee consensed to re-nominate Jared Laiti as our Liaison to the Secretary of State

TIMELINE/RESOURCES: Greg Jan (or another Coordinating Committee member) will inform Jared of the GA's decision. No other resources or steps are needed.

APPENDIX D

ITEM REGARDING GPCA ENDORSEMENT OF DR. BUTCH WARE FOR GOVERNOR

SPONSOR: Candidates Committee

PRESENTER: Greg Jan, [Alameda County]

SUBJECT: Endorse Dr. Butch Ware for Governor

BACKGROUND AND PURPOSE: As most of you know, Dr. Butch Ware formally announced his campaign for Governor several months ago, and he's been very actively campaigning since then. Butch later asked if we could endorse him, so we (the Candidates Committee), created a questionnaire (to be used for all statewide candidates), which Butch filled out, and which we found to be more than adequate.

Butch has already created an exceptionally strong campaign, with regular campaign events around the state, plus online events. He has done this earlier than any other Governor candidate we've had, and he also has a stronger early fundraising program and social media presence than our previous Governor candidates. He is campaigning as a Green and is explaining to people why it's time to break with the two-party system. Endorsing Dr. Butch Ware will benefit both his campaign as well as the Green Party of California.

PROPOSAL: That the GPCA endorse Dr. Butch Ware for Governor. This will enable the GPCA and Butch to build a strong, unified campaign effort. The GPCA will be able to unequivocally encourage voters to support Butch's campaign, and in coordination with it, we'll be able to better build the party at both the local and statewide levels. In addition, when we're asked whether Butch is "the Green Party's candidate for Governor?", we'll be able to clearly answer "Yes", instead of having to create an explanation about why we haven't yet given him our endorsement. Butch is already running a very strong, unprecedented Governor's campaign -- let's now endorse Butch and take advantage of this incredible opportunity to together build the Green Party here in California.

COMMITTEE DECISION: The Candidates Committee consensed to recommend that the GPCA endorse Dr. Butch Ware for Governor.

TIMELINE/RESOURCES: After the GPCA endorses Dr. Butch Ware for Governor, the Candidates Committee will inform his campaign about the endorsement, and will work with his campaign to coordinate GPCA involvement with it.
