1. Approbation de l'ordre du jour / Approval of Agenda

S Lawrence proposed moving the award of Prizes to just before the item "Update from advisory board".

Motion to approve agenda as amended moved by Deborah Curran seconded by Angela Cameron. Majority approved.

2. Approbation du procès-verbal de l'AGA de 2021 / Approval of Minutes of the 2021 AGM

No revisions.

Motion to accept the minutes moved by Deborah Curran and Seconded by Sarah-jane Nussbaum. Majority approved.

3. Rapport du Président / President's Report

The President reported on how the Board kept CALT afloat and functioning through a second year of academic and personal work disrupted by the pandemic. She indicated that the Board kept up on governance obligations, met regularly and are even feeling slightly energised in anticipation of the next academic year. In particular, she noted five items:

- Thanks to David and Richard who have engaged with the federation of law societies this year as the federation moves forward on their most recent plans that may effect law teaching across the country. Sonia has also been engaged with the federation process.
- We are engaged in board renewal and in retaining current experienced board members.

- We were excited to be able to accept submissions for and adjudicate our three annual prizes.
- We have planned a short series of summer events rather than a conference, details to follow. We will actively discuss plans for a conference next year, and will take into account where Congress is taking place, and where organisations like the CLSA and ACCLE will be holding their events.
- We have hatched a forward-looking plan for fees, memberships etc following the COVID hiatus.
- We have revitalised CLEAR, and have editors and a plan going forward to keep that publication up and running.

4. Rapport financier du trésorier/ Treasurer's financial report

Sara Ross delivered brief remarks about her Report (attached) noting that CALT had no revenue through the pandemic. Expenses consisted of some related to CLEAR's now completed digitization project, and to the effort to enable easier collection of membership fees via the website.

Motion to accept the Treasurer Report (annual financials): Angela Cameron. Seconder, David Sandomierski. Accepted by majority.

The Directors noted the excellent work done by the Treasurer in her role and thanked her.

5. Frais d'adhésion en 2022-2023 / Membership fees in 2022-2023

Sonia Lawrence (CALT Secretary) explained that we plan to restart membership at a low rate starting immediately following the AGM. We have a new system for collecting membership fees that we hope and expect will be more seamless than in the past and will make it easier for people to become members. The CALT president will reach out to Deans re supporting Faculty membership in CALT. The rates proposed are comparable to ACCLE and considerably lower than CLSA. Sonia Lawrence noted that the membership system we are using provides 12 months of membership, not a set year – 12 months from whenever the membership is purchased. David Wiseman (CALT Director) added that CALT is content with the decision to waive fees for the last two years over the pandemic and offering things to the law teachers community without financial burden, but ultimately we do need to protect revenue. The rates are a bit lower that they were in the past but that we are hopeful that we can have slightly lower rates if renewal is easier. Basil Alexander (member) asked how membership and conference fees would interact and Sonia Lawrence confirmed that this would continue similarly as in the past, that is, that in person conference fees would be lower for members and there would be the opportunity to purchase membership at the time of any conference.

6. **Mise à jour: Comité Consultatif / Updates from the Advisory Board**The meeting then heard updates from members of the Advisory Board at a number of schools in order to get a sense of what is happening across the country. These revealed a range of issues – a

number of Dean searches and interim Deans, physical plant concerns, concerns about the way that Law Schools are implicated in various lawyer regulation processes, new programs and courses, and efforts to take stock of what the pandemic has left us with.

- a. Deborah Curran, U Vic:
 - Programs: The first JD/JID class will graduate this year and has increased UVic's attention to legal pluralism in law teaching.
 - Dean: Prof. Val Napoleon has been an interim dean and will continue into the new year in that role while a Dean search takes place.
 - Curriculum Review: Curriculum review process four years long had a number of interesting proposals including suggestions around retooling first year around public and private some of which the Faculty may now take up.
 - Lawyer Regulation: The LSBC hired Jordan Furlong and recommendations are now in front of the
- b. Graham Reynold (UBC Allard)
 - Strategic planning: 1L workload is a critical piece of this, along with EDI initiatives.
 - Deanship: After a period where Janine Benedet ably served as interim Dean, they have a new person in the role Dean Ngai Pindell.
 - Lawyer Regulation: LSBC Report noted in the UVic report is also a concern at UBC Allard.
 - New Position: Allard has a research associate position which will welcome a woman judge from Afghanistan.
 - a. Return to In Person: In person graduation this May after a few years of virtual!

7. Wendy Parkes (Lakehead)

- Physical Plant: Aging building is one of many things on the table in Lakehead's strategic planning cycle.
- Upcoming events: Lakehead will host the Canadian Association of Law Teachers in October 2022 and is also hosting their bi-annual Indigenous Law Conference, this time focused on language law and soveriegnty.
- New courses: including land based program for incoming Indigenous students, courses in family violence, law and technology and aboriginal law in the north.
- Connection to Indigenous Community: Lakehead is home to a new DOJ funded Indigenous law and justice Institute, working with local stakeholders.

8. Adrien Habermacher

- Impact of Remote Teaching: Moncton had most of 2022 in person, but their reflection on the pandemic as a minority language school has led to new understandings of the importance of having presence on campus as key to reinforcing student language skills and other elements of the law school experience.
- Deanship: Moncton currently has an interim dean, with a Dean search coming in 7 months.
- Connections to Indigenous Community: Moncton was not in the forefront of efforts to connect to local indigenous communities and elders, but that work is now being undertaken in a good way.

9. Lisa Kelly (Queen's)

- Departures: Queen's sadly lost senior faculty member Arthur Cockfield and recently held a celebration of his life in person with his family.
- Admissions/Funding: The first cohort in new black student applicant stream has started and students are benefiting from and expansions in funding opportunities.
- New Hires: Queen's has two new hires coming to the Faculty, Oluwatobiloba Moody and Lindsay Borrows. Queen's Law also hired an inaugural Director of Indigenous Initiatives and Equity, Diversity and Inclusivity Programs, Stacia Loft.

10. Nayha Acharya

- Physical Plant: In addition to the pandemic, Schulich endured a serious sprinkler malfunction which created real physical plant problems for them.
- Teaching Development: They have been holding some faculty discussions on teaching
 - things about remote teaching that were helpful and might continue to be useful (e.g. flipped classrooms).
 - Discussions on trauma informed teaching and learning, including a survey. They are now building knowledge and capacity to respond to student trauma.
- Teaching Evaluations: Dal is working on holistc teaching evaluations so that is also on the table at the law school.
- New Courses: A new course in African Nova Scotian legal issues is now required but this leads directly to need for revamping in 1L because of workload concerns.

Treasurer's Report – CALT AGM 2023 re: 2022

Sara Ross, Treasurer

- 1. I'm happy to report that for the first year since the beginning of COVID-19, CALT had a moderate revenue of \$477 as opposed to a loss such as, for example, our loss last year of \$1516. This is due to our renewed collection of membership fees, which was paused over the past two membership cycles.
- 2. Our sole revenue source this year was from membership fees.
- 3. Our expenses were primarily dedicated to:
 - a. The website and payment for assistance in order to transition to a new payment acceptance platform, which was necessary in order to facilitate our ability to easily accept membership fees despite the new logistical limitations introduced by the online platforms that CALT had used previously.
 - b. Travel, which enabled CALT to send a CALT representative to the Federation of Law Societies meeting in Saskatoon.
- 4. Smaller expenses were incurred through:
 - a. Translation to produce a bilingual conference Call for Papers as well as other CALT communications.
 - b. Our annual membership fee to the Federation of Humanities and the Social Sciences.
- 5. Our conference last year brought in no revenue but also did not require significant financial investment other than a small fee for translating the Call for Papers.
- 6. Our bank account remains at a healthy balance, which also indicates that we were able to successfully emerge financially from the COVID-19 operating logistics.
