 where the HRA voted to approve the execution of a development and loan agreement under tax
 increment financing spending plan authority for the project; to authorize waiver of the 45-day
 notice period in the Early Notification System (ENS), approving the use of a project labor
 agreement, and approving an HRA budget amendment.
- <u>City of Saint Paul HRA Resolution (RES 22-1150)</u> that was approved at the July 27 HRA meeting
- <u>Letter of Support for the project</u> (CRC members voted to sign on in support at the June 28 Annual Meeting)

The committee requested that the following resolution be considered by the CRC Board:

The Saint Paul City Council recently waived the customary 45-day public notification period and authorized a \$1.4 million "forgivable" loan to the Listening House for the purchase and remodeling of the Red's Savoy location. While the CapitolRiver Council is in support of the Listening House project and understands its desire to expedite it in order for the facility to be operational by winter, the CRC also supports adequate public notification on issues which affect our neighborhoods. When the City doesn't follow the customary notification rules it can erode community trust in the City.

Therefore, be it resolved, the CapitolRiver Council objects to the City Council's waiver of the public notification period.

The following rules enable us to move through our agenda efficiently, while giving people with different opinions the opportunity to participate in the discussion. When we invite guests to participate, we ask that you also agree to the following:

- Turn off or silence cell phones.
- Wait to be recognized by the board chair before speaking.
- Only one person speaks at a time.
- Keep comments brief please stay within the allotted time on the agenda for committee updates and other agenda items, and keep other questions and comments to 1 minute.
- Keep comments to the agenda item that is being discussed.
- When you have given your opinion or asked a question, allow others time to give their opinion or ask a question before speaking again.
- Avoid making personal attacks or using disrespectful or offensive language.
- Unless otherwise specified in CRC Bylaws or policy, board action requires:
 - A motion by a board member, seconded by another board member (except that a motion by a committee does not need to be seconded).
 - Discussion by board members.
 - Discussion by the public at the discretion of the chair.

- A majority of board members must vote in favor of the motion.
- If a board member proposes one or more changes to a motion, the board must first vote on the proposed change(s) and then vote on the motion.
- If a board member makes a motion to end the debate on an agenda item and call the previous question, and if it is seconded by another board member, the board must vote on that motion without debate, and if a majority of board members vote in favor of the motion to call the previous question, the board must vote on the motion that was being debated.
