Call to Order, Introductions, and Meeting Minutes: CRC Board Chair Jess Grams (5:15-5:30 p.m.)

1. Welcome and Land Acknowledgement:

We acknowledge that this meeting is taking place on the ancestral homeland of the Dakota and Anishinaabe people, near the sacred convergence of the Mississippi and Minnesota rivers, known as B'dote. We also note that we are blessed to spend this time together in this place, which might not be possible for people who have other work or family responsibilities. We reflect on this to remember our responsibility and privilege to protect these spaces, and to maintain a respectful environment where all people feel welcome, safe, and able to access the process of decision-making in our work.

Annual Meeting Recap (5:35-5:40 p.m.)

6. The June 27 Annual Meeting included small group discussions, facilitated by Dionne Gharamu-Nruaachi, NEOO Partners, who is leading community engagement for The Downtown Alliance. Read the summary of feedback from the small groups.

Orientation: Brief Overview of CRC's Work and Nonprofit Background Information (5:40-6:15 p.m.)

- 7. CRC Executive Director Jon Fure will provide an overview of the contract with the City of Saint Paul and other aspects of our work.
 - Community Engagement Contract: CRC receives \$62,922 each year to provide services that work toward achieving the following goals:
 - Serve as a conduit of information between the neighborhoods and the City Council, HRA Board, Mayor, and City Departments.
 - Lead and implement high-quality planning and public policy decision-making activities, related to land use, housing, transportation, economic development, food systems, waste management, neighborhood livability, public safely, and the natural environment. This work ensures that the City's planning and public policy decision-making processes include diverse voices and a local perspective.
 - o Improved Neighborhood and City Livability and Sustainability -- engage the community in the concrete work of making the District 17 neighborhoods better and more sustainable places to live, learn, work, and play. Provide technical assistance and support for communitybased livability and sustainability initiatives, including but not limited to community gardens, place-making projects, neighborhood clean-up events, tree restoration projects, local library associations, etc.
 - Community Building -- build connections within and between communities. This work includes coordinating large neighborhood events, support for National Night Out and other block-level organizing, outreach to underrepresented populations, and technical support for small-scale community building initiatives.
 - o Participate in a peer support/best practices network composed of district councils or similar grassroots, place-based organizations in the region.
 - O Review and adopt policies and practices that intentionally create space for residents who currently are under-represented. Pursue systemic work that reflects the needs and priorities of residents who have been historically under-represented.
 - CRC Mission: Key words are "advisory group," "all District 17 stakeholders," "act on urban planning and community building efforts," and "shared vision." Some organizations provide direct services, and others exist to do advocacy on specific types of issues or to provide benefits to duespaying members. CRC is different in that we serve all stakeholders.
 - CRC Inclusion Plan: Diversity, Equity and Inclusion aren't just trendy words that we use. Our
 contract with the City requires us to have diverse perspectives, and we want our actions to match our
 words. <u>Please review the CRC Inclusion Plan</u>
 - Committee overview: CRC currently has the following committees -- Public Realm (meets the first Thursday of the month at 5 p.m.), Skyway Governance Advisory (meets the fourth Friday of the month at 9 a.m.), Development Review (has not met in a very long time, used to meet on the second Tuesday at 9 a.m.), Officers Committee (meets at least quarterly), Strategic Planning (has not established a regular meeting date and time), Listening Session Planning Group (has not met since February 2023), Recruiting Committee (recruiting is often discussed in Officers Committee

meetings), and Public Bathroom Task Force (has not established a regular meeting date and time). The board may consider adding committees or task forces, or making changes to existing committees.

- Other local government advisory groups: The City of Saint Paul, Ramsey County, and the Met Council all seek community members to serve on various boards. CRC board members are encouraged to explore ways to serve, and to be a conduit of information that is related to your service in the community.
- Engagement in partnership with other organizations:
 - Sears redevelopment (collaborative efforts with adjacent district councils, the CAAP Board, and other organizations)

Key concept: A nonprofit's board of directors is responsible for developing, defining, and reviewing the organization's mission and for providing overall leadership and strategic direction to the organization. Boards are not owners of the organization but are stewards of the organization's mission and resources.

Please review the <u>CRC Code of Conduct</u>. The CRC Officers recently discussed potential strategies for addressing disrespectful behavior in our meetings. Rules of Procedure

Welcome to our meeting! When we make decisions as a group, we want all board members to have the opportunity to participate in the discussion. The following rules enable us to move through our agenda efficiently, while giving people with different opinions the opportunity to participate in the discussion. When we invite guests to participate, we ask that you also agree to the following:

- Turn off or silence cell phones.
- Wait to be recognized by the board chair or other presenter / facilitator before speaking.
- Only one person speaks at a time.
- Keep comments brief.
- Keep comments to the agenda item that is being discussed.
- When you have given your opinion or asked a question, allow others time to give their opinion or ask a question before speaking again.
- Avoid making personal attacks or using disrespectful or offensive language.
- Unless otherwise specified in CRC Bylaws or policy, action requires:
 - A motion by a member, seconded by another member.
 - Discussion by members.
 - A majority of members must vote in favor of the motion. The presiding officer determines if the
 majority has voted yes or no. A member may request that people raise hands if a vote is too
 close to determine.
 - If a member proposes one or more changes to a motion, the group must first vote on the proposed change(s) and then vote on the motion.
 - If a member makes a motion to end the debate on an agenda item and call the previous
 question, and if it is seconded by another member, the group must vote on that motion without
 debate. If a majority of members vote in favor of the motion to call the previous question, the
 group must vote on the motion that was being debated.
