## Annual Meeting Recap

6. The June 27 Annual Meeting included small group discussions, facilitated by Dionne Gharamu-Nruaachi, NEOO Partners, who is leading community engagement for The Downtown Alliance. Read the summary of feedback from the small groups.

## Orientation: Brief Overview of CRC's Work and Nonprofit Background Information

7. CRC Executive Director Jon Fure provided an overview of the contract with the City of Saint Paul and other aspects of our work. The process is similar to a grant application, where the City Council has already approved the funding. Each year, a work plan, budget and other documents are sent to City staff, who review it, and when it is approved and a contract is signed, CRC can then request reimbursement for eligible expenses. The board has discussed preparing that work plan in the fall, so that board members are more involved in creating the work plan before it needs to be submitted to the City, so the goal is to have those conversations in September or October. Board members were also asked to review the CRC Inclusion Plan. Another way that CRC board members can serve as leaders in the community is to serve on other local government advisory groups. The City of Saint Paul, Ramsey County, and the Met Council all seek community members to serve on various groups. CRC board members are encouraged to explore ways to serve, and to be a conduit of information that is related to their service in the community. CRC also works collaboratively with other organizations, such as the Capitol Area Architectural Planning Board and other district councils. on September 24, from 1:00 - 5:00 p.m. (an event that we are coordinating with the West Side Community Organization).
