CCSAI proposed to discuss the legality of honorariums for the Board of Directors. The Executive Director responds to the question from CCSAI and mentions that Board Members are compensated as part of the executive positions with their home Student Union/Association.

STFXSU yields speaking rights to the CASA Board Chair. STFXSU yields speaking rights to the Board Treasurer. CSI yields speaking rights to the Director-at-Large, Membership.

ASU speaks in favor of the points provided by the Director-at-Large, Membership and acknowledges the differences between Student Unions/Associations.

SAMU asks if schools in Atlantic Canada are discouraged from taking Board roles due to financial constraints. STFXSU responds by mentioning that many Atlantic Canada schools are often paid less than the national average.

CCSAI asks if there could be a written guide from the Membership Committee to outline the different ways Student Unions are compensated. AUSU mentions that this should be a conversation moving forward.

CCSS recognizes the Executive Director. STFXSU recognizes the Board Chair.

CCSAI would like to table the discussion to take place after plenary.

RRCSA recognizes the speaking rights of the Board Treasurer. The Treasurer proposes to do a closing roundtable.
