- You must be a CCTA Member or pay a \$10.00 Guest Fee to participate.
- **Entry Deadline: Monday, June 5, 2023 at 10:00PM.**
- Entry fee must accompany all entries.
- Players may enter two events; singles, doubles and/or mixed.
- Partner's name must be included, no "And Partner" entries.
- **If the Tournament Director can put you in after the entry deadline there will be an additional \$10.00 charge.**
- Draws will be posted Thursday, June 8 at 12:00 PM noon at [centralvalleytennis.org](http://centralvalleytennis.org)
- Players are responsible for being on time for all matches  
 (The 15 minute default rule will be strictly enforced)
- All matches to be best 2 out of 3 sets, with a 10 point tiebreaker in lieu of a third set, regular game scoring, 12-point tiebreaker at 6-all.  
 (The Tournament Director may change format due to time constraints)
- Consolation will be offered in all events.
- Grand Prix points will be awarded for the CCTA Tournament Year
- This tournament counts for 2 CCTA Qualifying Tournament Points
- No refunds after draws are complete.
- Please report to the tournament desk at least 15 minutes before your match.
- All Copper River, CCTA & USTA rules govern conduct and play.
- Proper tennis attire must be worn (no tank tops for men, cut-off shirts or black soled shoes).
- Round-Robin format will be made for draws with 3 teams /players.
- Copper River facilities are available for **members only**.
- If draw size requires, play may begin Friday, June 9 after 6:00 PM.
