Tournament Notes:

- You must be a CCTA Member or pay a \$10.00 Guest Fee to play.
- Entry Deadline: Monday, April 28, 2025 at 10:00 PM.
- Entry fee must accompany all entries.
- Players may enter two events; singles, doubles and/or mixed
- Partner's name must be included, no "And Partner" entries.
- If the Tournament Director can put you in after the entry deadline there will be an additional \$10.00 charge. (Shirt not guaranteed for late entries)
- Draws will be posted Thursday, May 1 at 12:00 PM Noon at [www.centralvalleytennis.org](http://www.centralvalleytennis.org) and at the club.
- Players are responsible for being on time for all matches (The 15 minute default rule will be strictly enforced)
- All main draw matches to be best 2 out of 3 sets, with a 10 point tiebreaker in lieu of a third set, regular game scoring, 12-point tiebreaker at 6-all. Consolation to be 8 game pro-sets. (The Tournament Director may change format due to time/court constraints).
- This tournament counts for 1 CCTA Qualifying Tournament Point.
- No refunds after the entry deadline.
- Please report to the tournament desk at least 15 minutes before your first match.
- All Club, CCTA & USTA Rules will govern play.
- Proper tennis attire must be worn (no tank tops for men, cut-off shirts or shoes that leave marks).
- First match loser consolation in all draws except round-robin.
- Round-Robin format will be made for draws with 3 teams / players.
- Fig Garden Swim & Racquet Club facilities are available for **members only!**
- If draw size require, play may begin Friday, May 2, 2025 not before 6:00 PM.
- Shirt included for all participants.
- Fig Cafe available for purchases.
- Consolation will be offered in all events.
- Grand Prix points will be awarded for the CCTA Tournament Year.
