Rules & Information:

- You must be a CCTA member or pay a guest fee to play. (Excludes Open Divisions)
- Submit the top portion of this entry form and retain the bottom portion for your records.
- If the tournament director can put you in after the deadline there will be an additional \$10.00 charge.
- Partner's name must be included on entry form in designated space (no "and partner" entries)
- No refunds or credits after the entry deadline.
- Entry fee must accompany all entry forms.
- No phone or fax entries will be accepted.
- Players may enter three events; one singles and two doubles. However; one doubles must be mixed.
- Entry Deadline is Monday, August 31st by 10:00PM
- Draws will be posted Thursday, September 3rd at Sierra Sport & Racquet Club and the CCTA website centralvalleytennis.org
- It is the players responsibility to check for their starting times. Absolutely NO starting times or other draw information will be given over the phone.
- Proper tennis attire must be worn (no tank tops for men or cut off shirts) NO running shoes or black soled shoes!
- All matches will be 2 out of 3 sets, regular scoring (no ad scoring may be used in earlier rounds). Open Divisions to play full third. 12-point tiebreaker at six all. (The Tournament Director reserves the right to change the format of play for time/court restrictions)
- Club facilities are available for **SSRC MEMBERS ONLY**.
- Tournament committee reserves the right to move players or teams up to the next level of play.
- Please report to the tournament desk at least 15 minutes before your first match. 15 minute default rule will be enforced.
- All Club & USTA Rules will govern play.
- Mixed Combinations: 9.0-5.0 & 4.0 or 4.5 & 4.5; 8.0-4.5 & 3.5 or 4.0 & 4.0; 7.0-4.0 & 3.0 or 3.5 & 3.5.
- Prize money paid out to Open Divisions.
