- Players must be CCTA Members or pay a \$10.00 Guest Fee.
- **Entry Deadline: Monday, September 14 at 10:00PM.**
- Entry fee must accompany all entries.
- Partner's name must be included, no "And Partner" entries.
- **If the Tournament Director can put you in after the entry deadline there will be an additional \$10.00 charge.**
- Draws will be posted Thursday, September 17 at 12:00 PM Noon at www.centralvalleytennis.org
- Players are responsible for being on time for all matches (*The 15 minute default rule will be strictly enforced*).
- Overflow matches may be played at Abraham Lincoln Middle School in Selma on either Saturday or Sunday. The Tournament Director will send these matches from Selma High
- All matches to be best 2 out of 3 sets, with a 10 point tiebreaker in lieu of a third set, regular game scoring, 12-point tiebreaker at 6-all. The Tournament Director may change match format to 8 game pro-sets due to time constraints.
- Consolation will be offered in all events.
- Grand Prix points will be awarded for the CCTA Tournament Year.
- This tournament counts for 2 CCTA Qualifying Tournament Points.
- No refunds after draws are complete.
- All CCTA & USTA Rules will govern play.
- First match loser consolation in all draws except round-robin.
- If draw size require, play may begin Friday, September 19, 2026 at or after 6:00PM.
