

Learning for forcibly displaced children and young people in the Commonwealth Call for Evidence

The <u>Council for Education in the Commonwealth (CEC)</u> is pleased to share this call for evidence on learning for forcibly displaced children and young people in the Commonwealth.

Background

Millions of children and young people find themselves on the move every year. In 2020, there were 36 million international child migrants, including nearly 17 million refugee and asylum-seeking children and young people. The Commonwealth itself is home to countries hosting some of the world's largest refugee populations, including Uganda and Pakistan, and countries with high populations of Internally Displaced People (IDPs), including Nigeria. The Commonwealth is also affected by new challenges that can lead to displacement, including climate change. Indeed, Small Islands States across the Commonwealth are at the forefront of policy development to support populations affected by climate change-related displacement.

CEC is interested in understanding the impacts that forced displacement has on children and young people's access to learning in the Commonwealth. Acknowledging that expertise on this topic is held by a wide array of individuals and organisations across the Commonwealth, CEC has launched this call for evidence to crowdsource knowledge. The submissions will be used to develop a forthcoming advocacy initiative on learning for forcibly displaced children and young people in the Commonwealth.

Scope

The call for evidence is seeking information related to learning (including formal and non-formal education) for forcibly displaced children and young people aged 0-19 in the Commonwealth.

Questions

- What challenges do forcibly displaced children and young people in the Commonwealth face in accessing learning?
- What challenges do forcibly displaced children and young people in the Commonwealth face in terms of the quality of learning?
- What non-academic challenges do forcibly displaced children and young people in the Commonwealth face that contribute to, or result from, limited access to quality education?
- How can the Commonwealth, including Member State leaders and policymakers and the
 Commonwealth Secretariat, ensure better learning opportunities for forcibly displaced children?
- What **one issue or intervention**, if addressed, would best ensure forcibly displaced children and young people in the Commonwealth could access quality learning?
