Division 7 Pull-Outs

<u>Division 7 buses scheduled to pull-out via Westbound Santa Monica Blvd.</u>

Exit Division 7 yard via L-San Vicente Blvd., R- Beverly Blvd. to Santa Monica Blvd. and regular route.

Division 7 bused scheduled to pull-out via Eastbound Santa Monica Blvd.

Exit Division 7 yard via L-San Vicente Blvd., L-Beverly Blvd., L-Fairfax Ave., R-Santa Monica Blvd., and regular pull-out route.

Line 2 buses scheduled to pull-out to San Vicente Blvd. and Santa Monica Blvd.

Exit Division 7 yard via L-San Vicente Blvd., R-Beverly Blvd., R-Doheny Dr., R-Sunset Blvd. to San Vicente Blvd. and regular route.

Division 7 Pull-Ins

Via Northbound San Vicente Blvd., R-Division 7 West driveway. Operate clockwise around the yard at 8 mph to either the fuel lanes or the temporary layover zone on lane 20.

Make passenger stops at all intersections where it is safe to do so while on detour route
