Over the Thanksgiving holiday the indoor pool boiler started short-cycling. It was having difficulty maintaining the 84°F temperature in the pool because it was continuing to shut

off. Sweetwater Pools came out and found that the impeller blade needed to be replaced. After changing out the impeller, the system would run longer but it would still short cycle. The emergency repairs for the impeller cost \$2,096. Sweetwater pools handed it over to Wilbanks, an actual boiler company, who supplied a quote for labor, check valve, threeway mixing valve, actuator, and misc. materials needed to install in the boiler. They are also going to clean out the boiler. This is the boiler that we purchased in 2017, right after the hurricane. The total price for the repairs needed is \$4,365.

Due to the increase in pool chemicals, we have researched how much the chemicals have gone up over 3 years. They have gone up by 90%. We are looking at increasing the aquatic class prices by about 40%. We haven't increased the cost of the classes in a few years and even with an increase, we will still be much lower than the other local classes.
