# General Manager's Report

We are working on getting an exemption on taxes for the Friendswood Ranch property.

Summer Camp – The camp inspector came out on 15 July 2022 and notified us that the TX Department of State Health Services now requires us to offer two hazardous activities in order to receive a license for Day Camp. They are looking at offering archery or another type of ropes course that comes with a certified trainer. If we do not have two hazardous activities, we will have to obtain a license for Daycare, which requires more regulations to pass inspection.
