President's Comments

Treasurer's Report

We needed to make a down payment/retainer for IIVAC and other repairs in the gym. \$50,000 was transferred from UBS to the BOA Operating Account. The remaining amount in the UBS Money Market Account is \$13,073.10. An additional \$50,000 was withdrawn from the Shell Federal Credit Union and deposited into the operating account. A check for \$104,600 was written to Primo Air Masters for work on the gym HVAC. A second check for \$30,520 was written to Aqua Answers for the remodel of the dive pool, lap pool, etc.

General Manager's Report

March collections for past due assessments: \$7,586

March collections from Legal: \$21,239 Transfer fees and refinance fees: \$16,425

Resale certificates: \$2,350

Total: \$47,601

491 people have paid their assessments online.

The Annual CLCCA Election has been posted on the CLCCA Website and bulletin board. Applications are available in the gym office and online. The deadline to appear on the ballot is 5pm on 21 April 2023. Early voting is 04-05 May 2023 from 11am-7pm. The Annual Election is on 06 May 2023 from 7AM-7PM. Earl Ehlers has agreed to be the judge.

Aqua Answers has begun replastering the outdoor pools. The welder is in the process of repairing the slide stairs and platform. Primo Air has placed the order for the new gym A/C system. Classic Sports has us scheduled at the end of the month to repair the Rutledge Park tennis courts. The park lighting is scheduled to be repaired next week.

We are having difficulty finding lifeguards, as are other organizations. We have reached out to several Lifeguard Management companies to see if they could assist in supplying lifeguards until we can secure several of our own. They are very expensive. Pool opening hours will be adjusted over the next 4-6 weeks.

We are going to have the Memorial Day Opening Bash on 27 May 2023 in conjunction with our 60th anniversary. We are going to have food trucks and a raffle as a part of the celebration.

Our first Senior Social program was 04 April and will continue every other Tuesday. Raising Cane's provided lunch, the first week and will provide drinks thereafter. Lunch will be available from 11am to 1pm. All seniors 55+ are welcome to attend.

<u>ACLC</u>: Texas House Bill 92 is pending and states that a municipality or HOA may not prohibit growing fruits or vegetables on a property and also cannot prohibit raising or keeping six or fewer chickens, or six or fewer adult rabbits. They also cannot prohibit installing a solar energy device, a rainwater harvesting system, or a standby electric generator.
