General Manager's Report

This month through internal collections we have sent out 738 demand letters and 31 209 letters. Thus far we have collected over \$40,000 from in-house collections this month.

Rachel found a clause in the proposed janitorial contract that they use sub-contractors. She is asking for clarification to find out who they will be using. A change in contractors is needed to reduce costs.

We are reviewing security options at the recreation center. This includes canceling the security equipment with Xfinity and purchasing updated equipment to eliminate the monthly charges.

The Sportcourt tiles were removed and the Taraflex gym floor was installed. Walk-off tile was purchased for two 6ft. apron areas at the front and the back of the gym. The walk-off tiles will be installed by Shannon and Nathan.

The Fall Festival was a big hit. Total net profit was \$5,422.

HPD PIP: Leslie was not able to attend.

<u>ACLC</u>: ACLC discussed the laws that were passed in the sessions in the spring. There is no December meeting and the next meeting will be in January.
