1	Immigration	We have seen unprecedented efforts by government and corporate actors to secure data about those who are voting or seeking protections and benefits afforded by Colorado. Regardless of whether those efforts come about because of a desire to undermine the integrity of our elections or target immigrant communities, if elected, will you commit to using all your efforts to protect data about Coloradans from disclosure? 2	Immigration	Will you support and sign a bill that allows Coloradans to sue federal officials when their constitutional rights are violated, including the right to compensation for reasonable attorney fees?	YES	YES
3	Housing	Mobile home parks in mountain communities are selling to private equity for outrageous prices, because investors know they can double the rent immediately. State law prohibits municipalities from regulating residential rents. If elected, will you support lifting that ban as it pertains to mobile home parks and allow local governments to place an annual cap on lot rent increases?	YES	YES
4	Housing	The Mobile Home Park Act gives residents four months to come up with an offer if their park goes up for sale. However, DOLA's process to award and disburse Proposition 123 funds takes 6 months to a year. The system is broken, resulting in less than 0.2% of Prop 123 funds invested in preservation. If elected, will you work with us to fix this process to save the last form of affordable housing in many Colorado communities?	YES	YES
5	Housing	To preserve base levels of funding for homelessness prevention services, during your first term as Governor, will you commit to including at least \$30M for emergency rental assistance, \$10M for emergency foreclosure assistance, \$2M for eviction legal defense, and \$1M for foreclosure legal defense in each annual budget, utilizing both the Colorado State Budget and Proposition 123 funds? 6	Education	Will you actively support ballot measures and/or legislative changes to state revenue policy in order to increase funding for public education?	YES	YES
7	Education	Education Support Professionals, the lowest-paid school employees, can no longer afford healthcare insurance. CEA members want to pool healthcare across all Colorado school districts to implement a statewide plan to decrease the cost of healthcare for all educators. If elected, will you support this effort and work with us to make it happen?	YES	YES
8	Education	When private market ideology drives public education policy, we end up with laws like those where individual teacher evaluations are tied to test scores, which fail to recognize the multiple factors and complexities that influence student achievement. If elected, will you support an accountability system that separates individual teacher evaluation from average test scores, like almost every other state in the US?	YES	YES
9	Workers' Rights	If elected, will you support, and sign into law, legislation that gives all public sector workers full collective bargaining rights?	NO	YES
10	Workers' Rights	We are the only state in the country that requires a second election to form a strong union, creating a major obstacle to workers' right to organize. Coloradans for the Common Good and Colorado Workers Rights United partners commit to bringing the next Governor's desk a bill that would eliminate Colorado's second election as it pertains to union security. 1	Workers' Rights	Will you commit to setting up a strategic enforcement unit targeting misclassification of gig workers?	YES	YES	YES
2	Workers' Rights	Will you commit to issuing a formal opinion that all state employees must be paid the applicable local minimum wage when working in jurisdictions where such a local wage exists?	NO	YES	YES
3	Housing	Tech companies have been reshaping the rental market by developing exploitative rent price-fixing algorithms and AI systems based on non-public information. They then pressure landlords to align the amounts they charge for rent with this data. In 2025, Governor Polis vetoed the bill that would've outright banned the practice in Colorado. As Attorney General, will you commit to using existing Colorado and federal anti-trust law to hold accountable developers and deployers of this technology in Colorado?	YES	YES	YES
4	Immigration	Will you commit to making the full investigatory resources of your office available to local prosecutors so that they can hold federal law enforcement officers accountable when they violate Colorado law?	YES	YES	YES
5	Consumer Protection	AG Weiser worked with us to oppose and ultimately stop the merger between Safeway and Kroger because it was bad for consumers and bad for workers. Will you commit to forceful advocacy against increased corporate concentration, including by continuing to reject the FTC settlement reached with LiveNation, opposing further consolidation in local Colorado television markets, and challenging consolidation in corporate health care?
