#### **Find Out Who Your Representatives Are**

- Don't know your congressional district/ representative? Go to https://www.house.gov/find-yourrepresentative.
- Find out which of your state officials have received money from zionist lobbies by visiting boughtbyzionism.org.

#### **Disrupt Public Events**

- Targeting spaces where war criminals are present to interrupt regular or important programming.
- Set Google Alerts for different officials' names and check upcoming local events to see if they will be present.

#### Birdogging

- Seeking out elected officials and state specific questions or information to learn their views.
- · Can be done in public or digitally.
- · Record and share any responses.

## What is a "war crime"

"A serious violation of international humanitarian law committed during armed conflict" (Cornell Law School)

#### **International Humanitarian Law**

 Law based on international treaties. particularly the Geneva Conventions, that aim to limit the barbarity of war and protect civilians during armed conflicts

#### **Arms Trade Treaty**

- · Sets international regulations for the trade of arms
- States that nations must refrain from supplying weapons in conflicts if there is a clear risk of or awareness that the weapons will contribute to violations of IHL

#### **Examples of War Crimes**

- Torture and cruel treatment
- The murder of civilians and prisoners of war
- Sexual violence
- · Attacks on individuals and infrastructure not used for military purposes (E.g., medics, hospitals, religious buildings).
- Looting and pillaging villages in occupied territory
- · Using prohibited weapons such as chemical/biological weapons and certain kinds of landmines
- · Enlisting children under the age of 15 into the armed forces
- Targeting protected individuals like medics or objects like hospitals or religious buildings.
- Forced displacement of civilians

#### **International Criminal Court**

- The first and only international court with jurisdiction to prosecute individuals for international war crimes
- Does not replace national judicial systems but can exercise jurisdiction when national courts won't prosecute war criminals

### **U.S. War Crimes**

#### 2nd Trump Administration 2025-Present

- Launched a record-breaking 529 airstrikes within his first 5 months in office in Iran, Iraq, Syria, Somalia, and Yemen
- Bypassed Congress to send Israel billions of \$ in military aid.
- Cut funding for war crime accountability programs
- Sanctioned the International Criminal Court for investigating Israel's war crimes

#### Biden Administration 2021-2025

- Supported Israel's genocide in Palestine by sending massive amounts of military aid and weapons to Israel
- Hindered Ukrainian peace efforts,
- Violated the "War Powers Act" by launching military action against Syria
- Covered up and continued to support illegal actions in Libya, Yemen, and Iraq

#### 1st Trump Administration 2017-2021

- Escalated civilian deaths by weakening drone strike regulations and rules to protect civilians.
- · Backed illegal coups in Venezuela and
- Launched a March 2017 airstrike in Mosul that killed hundreds of civilians

#### Obama Administration 2009-2017

- Oversaw the expansion of drone strikes. leading to 10,000+ deaths in multiple countries
- · Killed U.S. citizens without trial.
- Intensified war in Afghanistan.
- · Led destructive wars in Libya and Honduras

#### **Bush Administration 2001-2009**

- · Launched and justified the illegal Iraq
- · Authorized a global torture program and mass surveillance.
- Detained and killed thousands without due process.

# Who pays for these crimes?


#### **#1: People living in the countries that** the U.S. has committed war crimes against

- Millions of civilians throughout the world living in post-9/11 war zones have died in their homes, waiting in line for food, standing in the street, in hospitals, etc. due to U.S. military intervention or aid.
- Millions more have been forcibly displaced from their home countries.
- · Women and children tend suffer the brunt of wars the most.

#### #2: The U.S. citizens whose tax \$ are being used to commit these war crimes

- · Historically, the U.S. has allocated 11%-90% of the U.S. federal budget to the Department of Defense, not including the costs for veterans' programs, homeland security, and other military-related activities.
- In 2024 alone, the U.S. government sent approximately \$17.9 billion in military aid to Israel.
