



### Request to Opt Out of Curriculum Content

Illinois law allows a parent/guardian the opportunity to review curricular materials and opt out of certain lessons/materials. A parent/guardian who believes that any instructional materials or programs violate rights guaranteed by any law or Board Policy may complete and submit this *Opt Out Form* to the Department of Learning & School Principal for such objection to be considered.

Parents who are seeking an exemption based on an "opt out" provision must complete Parts I and II of this form. Parents/guardians seeking an objection in accordance with the right to the free exercise of religious belief must complete Parts I and III.

Parents/guardians should submit this form to the building principal and the Assistant Superintendent of Learning.

- ☐ Recognizing and Avoiding Sexual Abuse, 105 ILCS 5/27-13.2 (K-8 only)
- ☐ Instruction related to Acquired Immune Deficiency Syndrome (AIDS), 105 ILCS 110/3
- ☐ Instruction on Cardiopulmonary Resuscitation (CPR) and use of Automated External Defibrillators (AEDs), 105 ILCS 110/3
- ☐ Organ/tissue and blood donation, 105 ILCS 5/27-23.5
- ☐ Lockdown drills, 105 ILCS 128/20\*\*

\*Students who are granted an exemption based on the “opt-out” related to the dissection of animals will be required to complete an alternative project. Such an alternative project/assignment will be of similar length and difficulty. Students who complete the alternative project/assignment will be graded in a manner similar to students using the original material.

\*\*Students who are granted exemptions from participation in lockdown drills will be provided with an alternative activity to address safety concerns related to an active threat.
