

My name is Christopher Gleason and I am over 18 years of age. I hereby declare under the penalties of perjury that the factual information contained herein is true and correct and that all opinion testimony is accurate to the best of my knowledge. The purpose of the following discussions is to illustrate the path

I have obtained and analyzed information pertaining to election financing for Maryland candidates and others from each state across the United States. The donations made by individual donors are reported to the Federal Elections Commission (FEC) from the collecting agencies and this information is provided to the public via a web-facing database located at <https://www.fec.gov>. As these donations are subject to control and regulation by Federal Campaign Finance Laws under (*statute here*) the aggregated data is maintained by the FEC within a separate database of these individual donor campaign finance contributions.

The data that will be discussed below is publicly available for verification and was obtained on January 13, 2023 from: <https://www.fec.gov/data/receipts/individual-contributions/> and <https://www.fec.gov/data/browse-data/?tab=bulk-data>.

The data that was collected and analyzed is comprised of individual and committee campaign contribution data. Queries are available to filter the large number of donations for activity that was made in a particular state or in a particular time frame. Each line that is produced on the queried reports reflects a single donation. The detailed data that is associated with each individual donation consists of the Contributor name, Recipient, State, Employer, Receipt Date, and Donation Amount. Additional data fields, such as the Contributor's address, are available if the query report is downloaded. The download function on the website produces the queried results in a .csv file format for further review and analysis. The FEC website is capable of displaying the queried data locally if the returned values are less than 500,000 records. For queries that resulted in more responses than 500,000 the resulting data had to be downloaded and reviewed outside of the web environment.

Evaluation results are based on the following provided fields:

**RECIPIENT NAME OR ID, CONTRIBUTOR DETAILS, NAME, ZIP CODE, CITY, OCCUPATION, EMPLOYER, REPORT TIME PERIOD, RECEIPT DATE RANGE, STATE OR TERRITORY**

Based on my investigations in other states, I filtered the data using the following criteria:

Employer: "NOT EMPLOYED"

Report Time Period "2021-2022" or "2019-2020"

State or Territory: Maryland

Recipient Name or ID: ACTBLUE

During the 2020 and 2022 Election cycles there were 2,741,000 reported individual donations to ACTBLUE by “NOT EMPLOYED” individuals in the State of Maryland. Adding other employer filters that would also represent “NOT EMPLOYED”, such as “N/A”

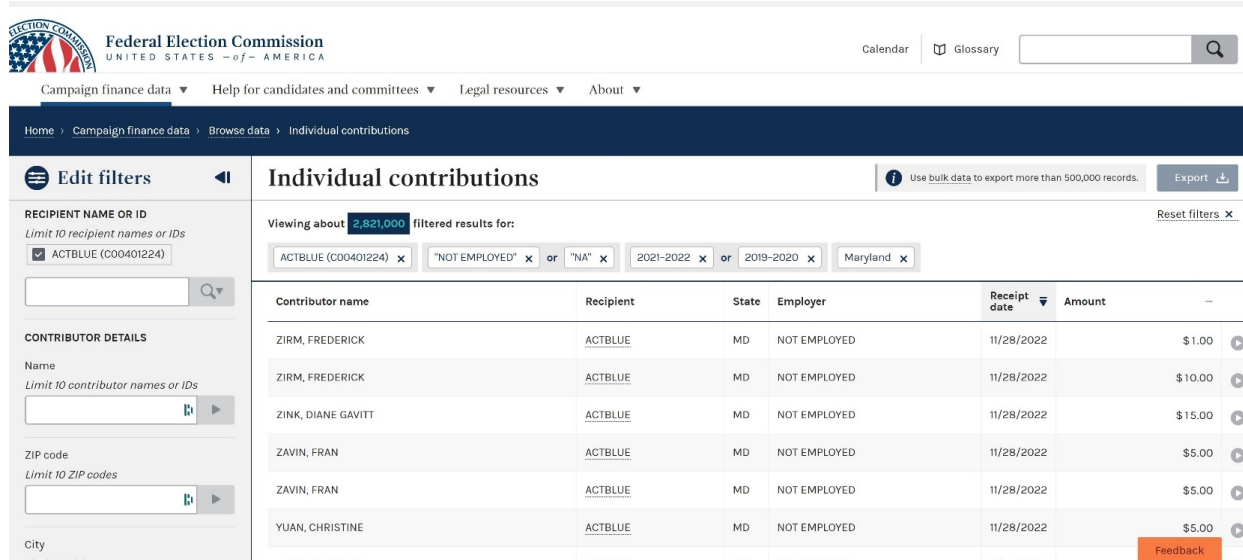


Figure 2: Increased results from additional “Not Employed” definitions

I then added an additional filter for Employer: “N/A”. The results increased to about 2,821,000 individual donations, as shown in Figure 2.

Upon further review into these “NOT EMPLOYED” individual donors, it became apparent that these donations were being made in an automated manner, with small amounts being made to multiple different “earmarked” funds. These donations were also made occasionally multiple times in the same day. The frequency of these small donations appear to be made with the use of programmatic algorithms.

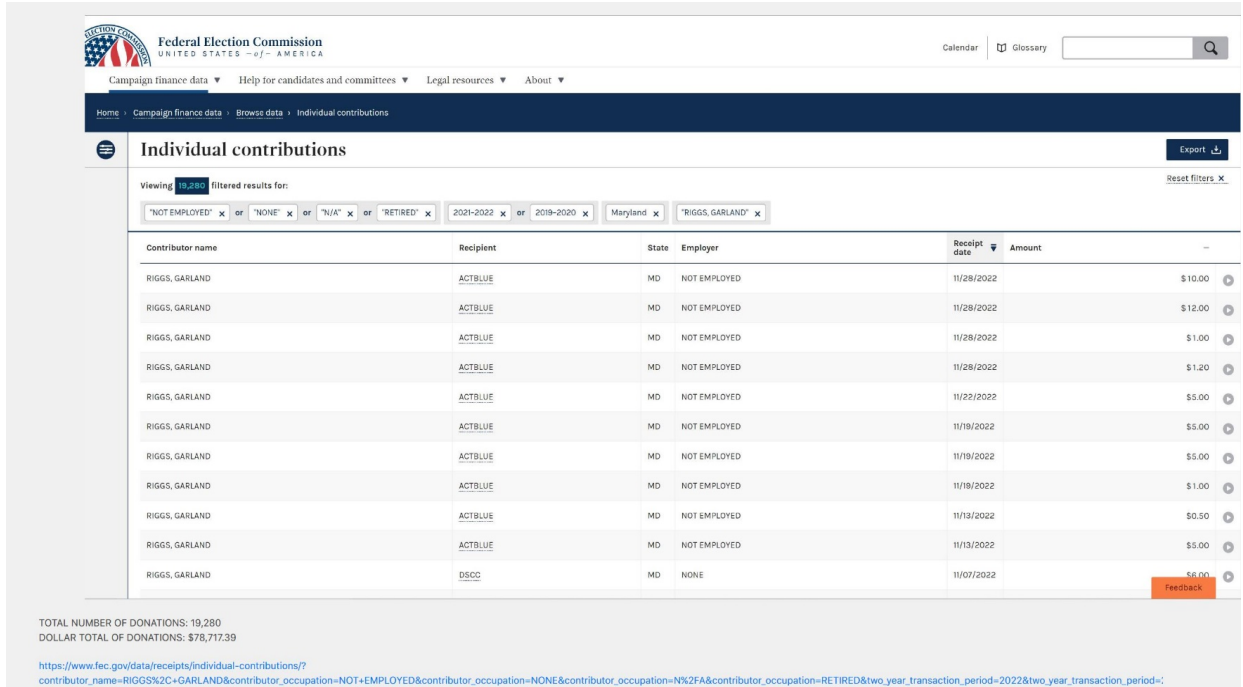


Figure 3: An example of a donor who made excessive contributions of small amounts

According to data obtained directly from the FEC database the “NOT EMPLOYED” individual donor in the image above donated 19,280 times during the 2020 and 2022

election cycles for a total of \$78,717.39. This pattern of individual donations has been observed in every single state that I have investigated across the entire nation. It also matches the patterns of “phantom voters” contained in the voter rolls.

The term “Phantom Voters” is a term used for individuals in the voter rolls that have been identified across America as using a “Legal Residential Address” and a “Mailing Address” that is not really their “Legal Residential Address” or their “Mailing Address”. This has been identified in the nationwide scheme to send vote by mail ballots to mailing addresses that are undeliverable and are being harvested then illegally being cast by bad actors in such volume as to materially affect the outcome of elections on the local, state and federal levels.

The image above reflects another “NOT EMPLOYED” individual donor who made 17,862 donations during the 2020 and 2022 election cycles totaling \$167,316.88. As in other states that I have found these same patterns of “mathematically impossible” legal individual donations I used open-source data and information available. The “Mathematically impossibility” of these donations can be shown through the identification of a particular “Pattern of Fraud & Illegal Activity” the individuals that we have identified that fit this profile are called “Campaign Finance Mules”.



The search results increased significantly to 21,049 when the filter for Employer: “NOT EMPLOYED” was removed. The total dollar amount of the individual donations made grew to \$209,728.52

Over a four-year period being reviewed in order to make this many donations an individual would have to make 5,262.25 donations per year. It would further show that the individual would have to make 14.417 donations per day for 365 days not taking any holidays or weekends off for the entire four year period.

In every single state that this pattern of illegal activity has been investigated, the FEC database shows individuals making individual contributions in such frequency and volume that these transactions are materially affecting the outcome of elections at every level. The use of these “Campaign Finance Mules” provides the ability for bad actors to exert great influence in our elections through the deployment of Dark Money from foreign and domestic sources.

The only logical explanation any reasonably prudent person can arrive at for the volume and frequency of these contributions by “NOT EMPLOYED” individuals is that someone is making these for them either directly or by the depositing of funds into the accounts that are being used to make these contributions.

This pattern of illegal campaign finance donations and money laundering activity is not limited to only “NOT EMPLOYED” individuals, this activity is also occurring with

individual donors who are employed as well. This has been documented in every single state that we have investigated up to this point.

The pattern of donations identified in Maryland was consistent with what has been observed in other states across the entire United States. Additionally, the beneficiaries of these large numbers of donations fit a very specific pattern as well. The candidates are typically democrat candidates and the PACs are often well known democrat PACs.

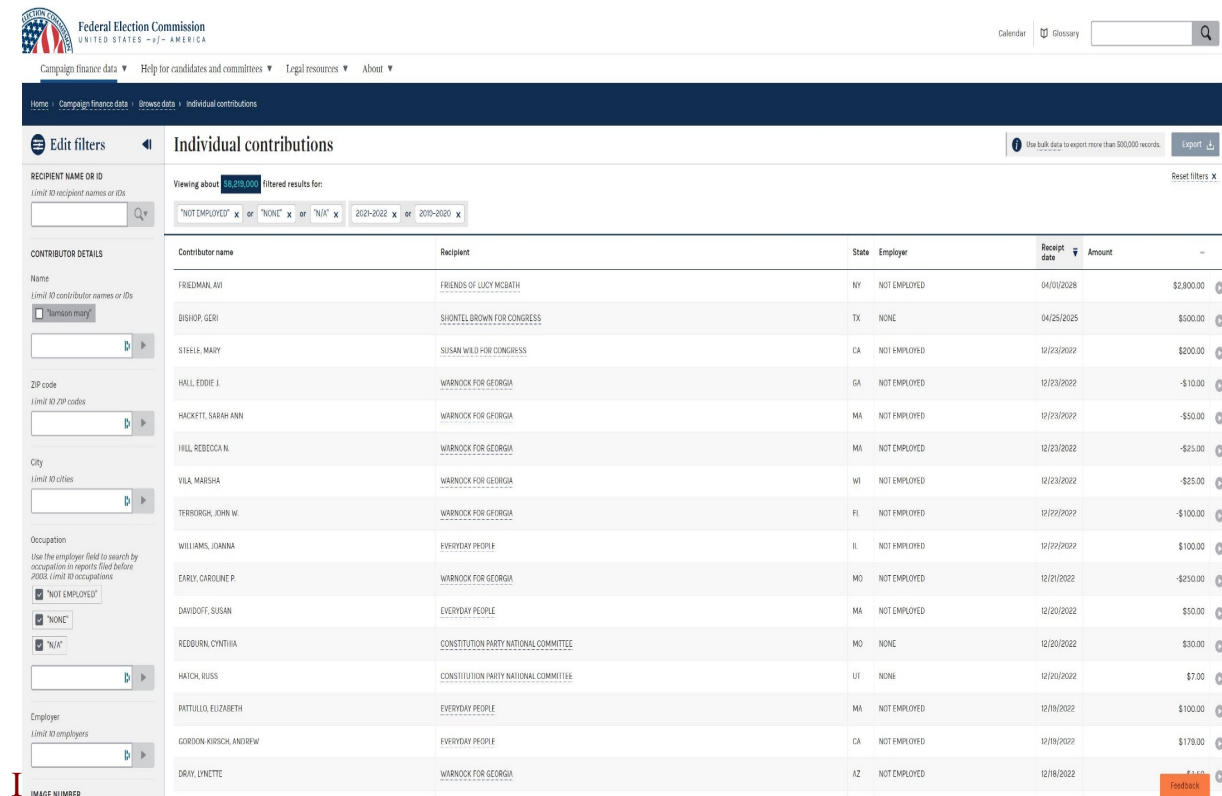

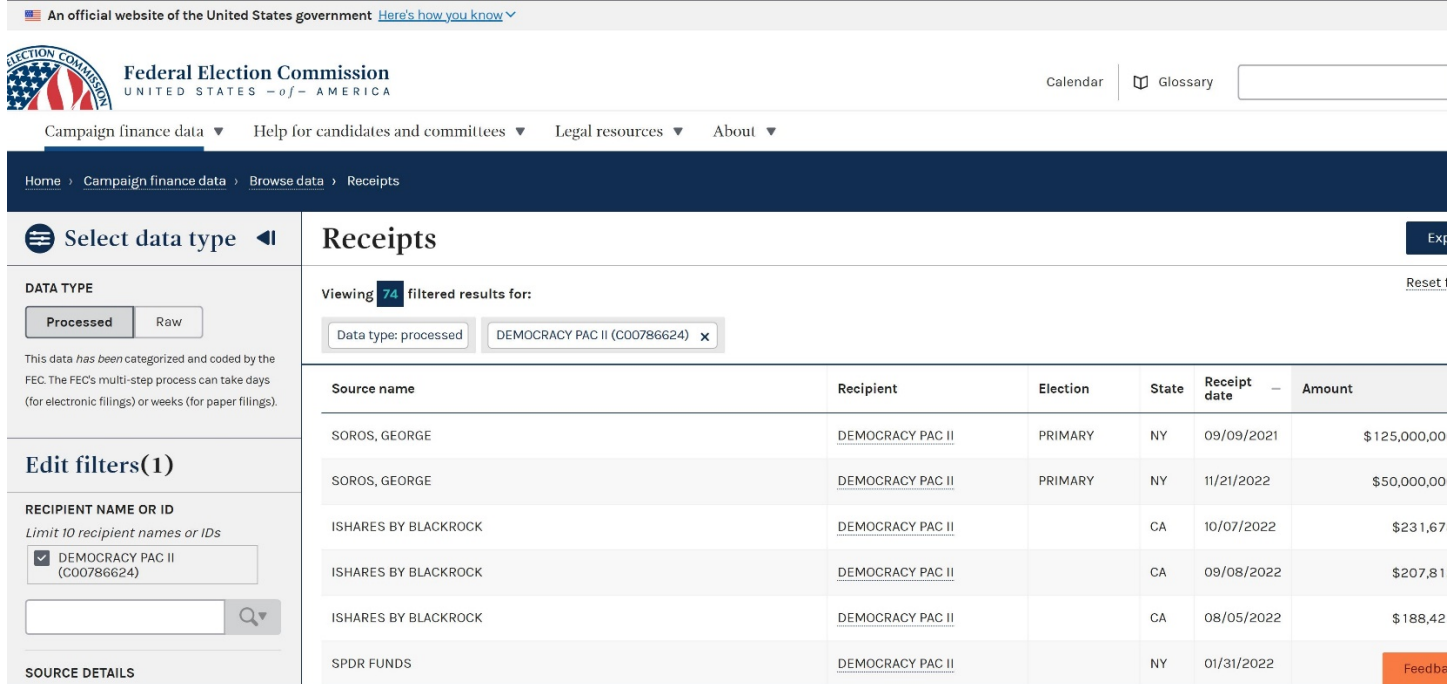

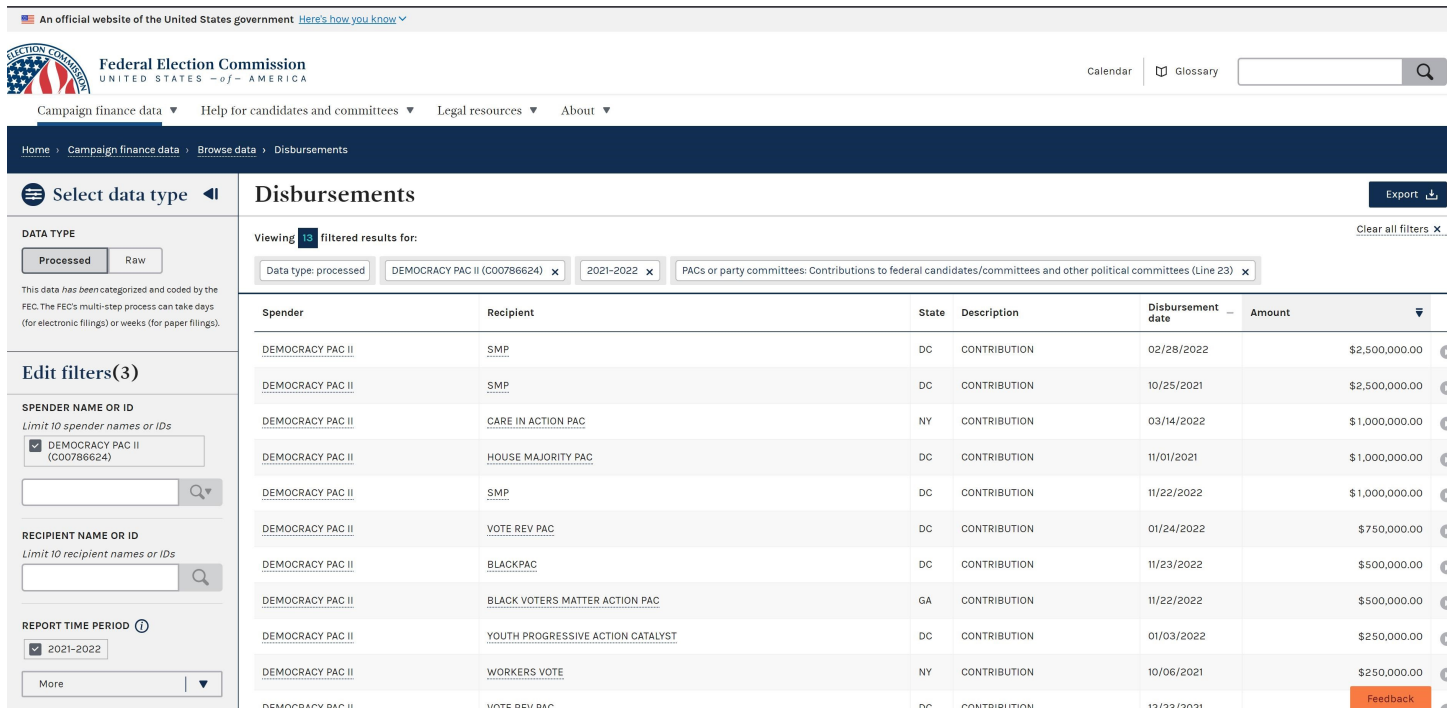

FAIR FIGHT PAC was also identified as a beneficiary of numerous similar donations by the individuals making high frequency donations. About 27,348 individuals who were “NOT EMPLOYED” made individual contributions.

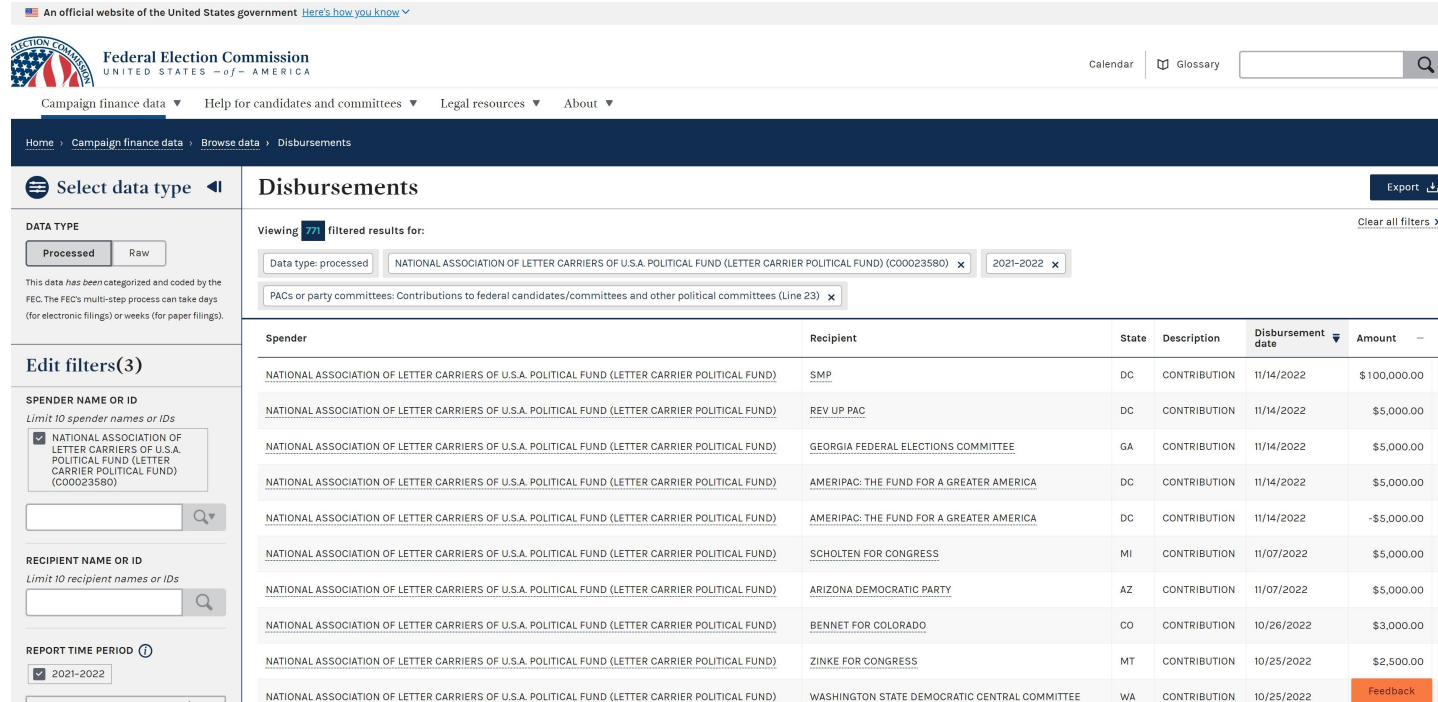

According to a research report put out by the Pew Research Center: <https://www.pewresearch.org/fact-tank/2017/05/17/5-facts-about-u-s-political-donations/> **Most Americans donate less than \$100.** Of all Americans who reported donating to a candidate or group working to elect a candidate, 55% reported donating less than \$100, while 32% reported donating between \$100 and \$250, according to the fall 2016 survey. The remaining 13% said that they donated more than \$250. Those who earn more also tend to donate more, however. Among those who donated, 27% of those with family incomes of \$150,000 or more said they contributed more than \$250, while 16% of contributors with incomes between \$75,000 and \$150,000 gave at least \$250. *Note: See full [topline results](#) from the Sept. 27-Oct. 10, 2016, Pew Research Center survey (PDF).*

The findings of the report by Pew Research Center explains why the individual contributions are structured in low dollar amounts as to evade recognition by regulators. The findings of the Pew Research Center report also validate the findings of this investigation suggesting that Americans making many thousands of individual campaign contributions is not possible and is evidence of a vast criminal conspiracy and enterprise of frauds, including wire fraud, voter fraud, campaign finance fraud, and money laundering.

Contributions to social welfare organizations which are similarly not cashed or affirmatively refused will be kept by ActBlue and used generally to support its social welfare activities. Contributions to charitable organizations which are not cashed or affirmatively refused will go to ActBlue Charities.

ACTBLUE is responsible for processing BILLIONS of dollars in payments for these individual campaign contributions. ACTBLUE keeps a running total of the funds

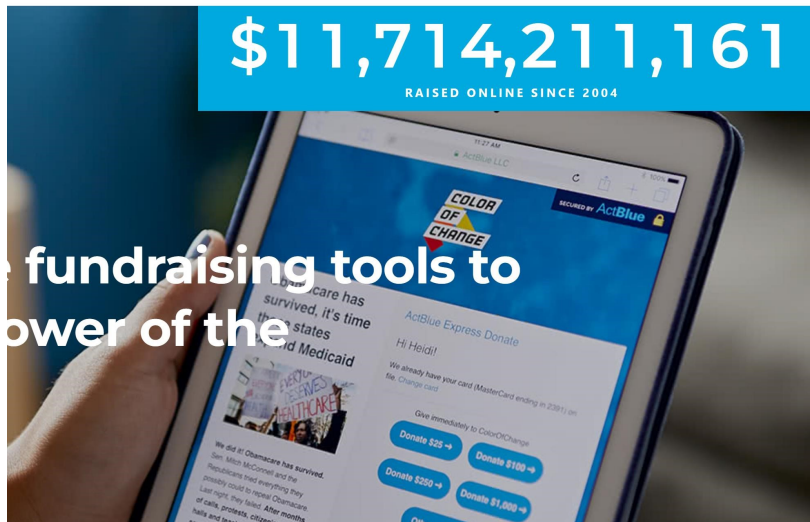

MAILING FRAUDULENT ABSENTEE BALLOTS

In the months leading up to 2020 election, CVI and its 501(c)(3), the [Voter Participation Center \(VPC\)](#), were widely criticized for mailing out partially pre-filled absentee ballots and voter registration forms in multiple states.

Fairfax County, Virginia, published a warning “about an inaccurate and potentially misleading mailing from the Center for Voter Information” in August 2020, noting that the group had mixed up the City of Fairfax with neighboring Fairfax County: <sup>[14]</sup>

*This group is mass mailing pre-filled, absentee ballot applications to county voters without their request—and the mailer includes return envelopes to send the application to the City of Fairfax, not Fairfax County.*

*“This mailing is causing great confusion and concern among voters who have been contacting our office,” said Fairfax County General Registrar Gary Scott. “While the mailing may appear to be from an official government agency, the Fairfax County Office of Elections did not send it.”*

*The mailing is also confusing voters who have previously submitted absentee ballot applications themselves, Scott added. These voters are worried that their applications were not received, leading them to think they need to apply again [emphasis original].* The Virginia Democratic Party wrote a public letter to the chairman of the Virginia State Board of Elections complaining that CVI’s absentee ballot mailers in Virginia “contain several errors,” confusing “Fairfax City and Fairfax County, Franklin City and Franklin County, Richmond City and Richmond County, and Roanoke City and Roanoke County.” According to the letter, CVI’s mailers also “contained incorrect middle initials or names for an unknown number of voters,” including that of the chair of the Democratic Party of Virginia’s Voter Protection Council. <sup>[15]</sup>

The *Washington Post* called CVI a “voter registration group with a history of sending error-ridden mailers” and criticized the group for having “again sown confusion in Virginia, this time tapping into concerns about mail-in-ballots sparked by President Trump’s repeated allegations . . . of election fraud.” The *Post* noted that while CVI and VPC are officially “nonpartisan,” “both organizations appear to be more aligned with efforts to defeat the president than with his allies.” <sup>[16]</sup> A great deal of these high frequency / volume donors were seen making donations to a PAC called Fair Fight. The top donor to Fair Fight was listed as giving \$145,000 on 11/01/2021. The name of this donor was Marjorie Rachlin. Upon further investigation I determined that Marjorie Rachlin was deceased. She had died 3 months prior to the date of her donation.
