## A RESOLUTION creating the Joint Study Committee on Run-off Elections; and for other purposes.

WHEREAS, the State of Georgia has seen increased scrutiny for its number of runoffs; and WHEREAS, the State of Georgia is one of three states with the option of holding general election runoffs; and WHEREAS, it is important to analyze the cost of runoffs in all state-wide, state legislative, and local races; and WHEREAS, study is needed to determine the best course of action with regard to runoffs; and WHEREAS, it is important that such study further emphasizes alternate options for elections to elect the best candidate, maximize voter participation, increase civility in elections, and save taxpayer dollars

- 9 members including: 1 the SOS or his designee, 4 appointed by the Senate President and 4 appointed by the House Speaker
- undertake a study of the conditions, needs, issues, and problems mentioned above or related thereto and recommend any action or legislation which the committee deems necessary or appropriate.

A BILL to establish the criminal offense of election interference with a deep fake and solicitation of such; to provide for definitions; to provide for exceptions; to provide for punishment; to provide for the State Election Board to publish results of investigations into such offenses; to provide for legislative findings; to provide for related matters; to repeal conflicting laws; and for other purposes.

Protection against the use of deep fake materials in bad faith to significantly influence elections by reducing certain candidates' chances of being elected or by suppressing voter turnout through mass confusion.

Repealing subsection (c) of Code Section 21-2-382, relating to additional buildings as additional registrar's office or place of registration for receiving absentee ballots and for advance voting and drop boxes.

- Employ and fix the compensation of personnel, including investigators, as determined necessary
- The Secretary of State shall, upon the request of the State Election Board, provide any and all necessary support, cooperation, and assistance

#### SB 355 Prohibit use of rank choice voting

- Defines 'ranked-choice voting' means a voting method that allows electors to rank candidates for an
  office in order of preference and has ballots cast be tabulated in multiple rounds following the elimination
  of a candidate until a single candidate attains a majority.
- Ranked-choice voting shall not be used in determining the election or nomination of any candidate to any local, state, or federal elective office

- revise the language that must be used on absentee ballot applications distributed by persons or entities making it clear that a ballot application is not a ballot
- revise provisions relating to advance voting on certain Saturdays preceding or following legal holidays
- revise the latest reporting time for required election night reporting from 10 pm to 11:59 pm
- mandate risk limiting audits following all state-wide primaries or elections
- penalize with a misdemeanor the willful neglect or refusal of a county or municipal election superintendent to call an election where required to do so by a local Act of the General Assembly

WHEREAS, a thorough study of the Dominion Voting Systems' electronic ballot marking devices is warranted so as to determine what appropriate revisions are needed to the Georgia Election Code to ensure that future elections remain free, fair, and timely while also protecting the rights of all Georgia voters to exercise the franchise to the fullest extent possible.

School Superintendent, Commissioner of Insurance, Commissioner of Agriculture,

Commissioner of Labor, Supreme Court Justice, Judge of the Court of Appeals, or

Public Service Commissioner;

- (iii) Member of the General Assembly;
- (iv) Judge of the superior court or district attorney;
- (v) County offices; and
- (vi) Municipal offices.

Provide for percentages of risk limits, lowering the risk limit percentages

Provide procedures for selection of contests subject to risk-limiting audits
