Favorito v. Wan

Fulton Co. 2020 Counterfeit Ballots

Senior poll managers found counterfeit mail-in ballots during Nov. 14, 2020 hand count

Ballots were not creased from being mails, not on correct paper stock, toner copied, & votes same way down ballots dozens in a row

We filed Equal Protection/Due Process lawsuit vs. BRE for vote dilution on Dec. 23, 2020

After 10 months, Judge Amero suddenly concluded we had no standing

GA Supreme court overturned Amero on Dec. 20, 2022



Favorito v. Wan

Fulton Co. 2020 Counterfeit Ballots

Amero transferred case to McBurney & we filed motion to recuse, Fulton Judge denied it

Fulton requested to destroy ballots after leasing new \$60 mil+ warehouse but were denied

Fulton told civil, criminal courts/SEB they preserved ballots but spent millions of taxpayer funds fighting subpoenas

We got ORR law changed in 2024 to unseal ballots and submitted ORR for them

They replied "no responsive records exist" so we sued Clerk

Greatest Voting Rights Violation in Georgia History



VoterGA v. Forsyth, Cobb, Coweta, Co. 2020 Original Ballot Image Destruction Case

VoterGA filed Open Records Requests for original 2020 ballot images to all counties

We found that 1.7 million original images were missing or destroyed across 70 counties

Election records must be preserved for two years under federal and state law

We sued the three most egregious violators for a copy of the actual 2020 ballots

Counties agree they should produce the ballots but want lots of money

Forsyth Co. wants \$49,000 to produce 2020 election ballots

Hearing set for Aug. 19



Broun, VoterGA v. Raffensperger Voter Data Outsourcing

Raffensperger outsourced voter registration data to 3rd party SalesForce cloud, Electronic Registration Information Center, Center for Election Innovation Research

There is no legal authority to outsource all voter data to a Salesforce cloud

Every read/write of voter data is vulnerable to interception, tampering

Raffensperger is also sending voter AND driver PII to ERIC without our consent

ERIC then sends it to CEIR so they can send us "election misinformation mailers"

SalesForce, ERIC, CEIR are highly partisan Soros / Zuckerbucks funded organizations



Favorito v. GA Counties Raffensperger 2022 Primary Election Challenge

Brad Raffensperger was polling 18-39% up until day before election

On Election Night the voting system gives him 51% of the vote to avoid runoff

A Dekalb Co. District 2 Commission candidate also got no votes in precinct where her family lived and voted so she requested a recount

The only primary hand count conducted found the system declared wrong winners

Raffensperger refused to audit any other 2022 primary races including his own

Our voting system has 0% accuracy rate in audited 2022 candidate primary races



Curling v. Raffensperger Dominion Voting System Constitutional Deficiencies

VoterGA's Ricardo Davis is original 2017 Plaintiff filed in Judge Totenberg's U.S. District court case

In 2019, Totenberg found paperless, unverifiable Diebold DRE system constitutionally deficient

Totenberg also found SOS office explanation for wiping the exposed election preparation servers clean just after trial started as "flatly not credible"

Court gave favorable rulings during 7 years and 3 trials including a 37-page analysis confirming standing of all Plaintiffs in Oct. 2023 just before January, 2024 trial

March 25, 2025, Judge Totenberg suddenly decides Plaintiffs have no standing

Ricardo files appeal also citing abuse of discretion in not allowing him to call witness, have attorney of his choice, etc.



Dekalb GOP v. Raffensperger Dominion Voting System Security

We are not a party but supplied the initial ORR evidence that initiated the case

Experts found Dominion stores encryption keys in clear plain text in a database

That violates original FIPS140-2, VVSG 1.0, 2005 guidelines under which the EAC was allegedly certified in 2019

Georgia law requires the system must be EAC certified and "safe for use"

Our Dominion Democracy Suite 5.5 voting system does neither
