 - In response to an email from Melissa Garcia, 29 November 2023, I wish to provide further information to support the previous application and request that the General Manager allow an additional period for lodgement of the alterations under Regulation 126 (1) of the Fair Work (Registered Organisations) Regulations 2009.
 - 2. The delay in lodging the application was due to the complex nature of the application and the limited resources of the organisation. A separate application for a similar rule change to the CSA's Rules was required to be made to the Western Australian Industrial Relations Commission which required additional resources. The Western Australian Industrial Relations Commission has approved the changes to the CSA rules.
 - 3. The rules of both organisations must operate in tandem for the purposes of their respective council's joint meetings.
 - 4. I did not interpret that the alterations were made 29 March 2023 as described in Ms Garcia's email, as the alterations only take effect on the date Fair Work approves them.
 - 5. The Council of the organisation have sought regular updates since 29 March 2023 on the application and remain committed to the change. The Executive Committee of the organisation passed the following resolution on Wednesday 13 December 2023 to reflect this continued commitment:
