

**SUMMARY OF BASIS FOR DECISION**

This memo summarizes my approach and reasoning for my decision as Chief of the Minneapolis Police Department that Officer Daniel Payne receive a Written Reprimand. This memo accompanies the enclosed MPD Worksheet.

**Policies Violated:**

**MPD 5-102.01 Minnesota Law Enforcement Code of Ethics**

**Facts Supporting Decision (see also Investigation Summary):**

On May 26, 2019, Sergeant Luis Porras was off-duty, driving his personal vehicle within the City of Apple Valley, MN. Porras was travelling on Granada Drive and turned into the American Legion parking lot at 2045 hours. Apple Valley Police Officer Sean Marben observed Porras as he drove without headlights on and failed to signal his turn into the parking lot. Officer Marben conducted a traffic stop.

Porras and his passenger exited the vehicle and approached Officer Marben. Through observations, field sobriety tests and a PBT, Officer Marben developed the probable cause to place Porras under arrest for 4th Degree DWI. Porras was read the Implied Consent Advisory and given a breath test. The result of the breath test was 0.13 BAC. Porras was booked and processed at the Apple Valley Police Station. He was issued a citation for 4th Degree DWI and released. Porras pled guilty to and was convicted of DWI-Alcohol Level at .08 or More, Minnesota State Statute 169A.20 1(15).

Upon the completion of this thorough investigation I reviewed the investigative case file materials and made my decision.

**Facts of this Case:**

- Porras drove his personal vehicle after he consumed four to five at an Apple Valley Sports Bar.
- Porras drove a short distance to the Apple Valley American Legion. Apple Valley Police Officer Marben conducted a traffic stop on Porras.
- Officer Marben established probable cause to arrest Porras for DWI.
- Porras gave a breath sample with a BAC of .13. He was cited and released.
- Porras pled to and was convicted of a misdemeanor DWI in Dakota County.
- Porras completed eight hours of DWI/Alcohol related education.
- Porras attended a MADD impact panel.
- Porras recognized the decision to drive under the influence as bad and acknowledged that it was 100% his fault.
- Porras looks back at the decision with remorse and embarrassment.
- Porras has learned from the decision to drive under the influence and made lifestyle changes.

As Chief of Police I am responsible for providing clear expectations on what is acceptable behavior in our workplaces as well as what will not be tolerated. Based on my review of the facts of this investigation and Sergeant Porras' statement of remorse and embarrassment I am suspending Sergeant Porras for 13.43 hours.

Be advised that any additional violations of Department Rules and Regulations may result in more severe disciplinary action up to and including discharge.
