SUMMARY OF BASIS FOR DECISION

This memo summarizes my approach and reasoning for my decision as Chief of the Minneapolis Police Department that Officer Alexander Walls receive a Written Reprimand. This memo accompanies the enclosed MPD Worksheet.

Policies Violated:

MPD 7-402(IV)(B)(2)(a) Pursuit Policy

Facts Supporting Decision (see also Investigation Summary):

On 9/18/2019, Officer Walls and Officer Thao were assigned to marked Minneapolis Police squad 123. Officer Thao was driving; Officer Walls was passenger.

Officer Walls and Officer Thao observed an "unlicensed Hyundai Sonata" exiting the parking lot located at 1530 6th Street South. ⁴ Officer Thao noted in his statement, "the area we were in had a history of stolen vehicle(s) by Somali juvenile males. The driver seemed to be a Somali juvenile male."⁵ Based off the recent events in the area, Officer Thao began to follow the vehicle.

Officer Thao followed the vehicle as it turned northbound on to 15th Av S, eastbound on to Riverside Parkway, then northbound onto Cedar Av S toward Washington. The vehicle made a west bound turn onto the 3rd Street South exit off of Washington Av S, going through a yellow light.⁶

Officer Thao stated the suspect vehicle sped up, passed two vehicles on the left hand side, crossing the double yellow dividing lines, to make a right hand turn onto 3rd Street S. Officer Thao activated the squad lights and sirens, then proceeded to catch up to the vehicle, which had exited onto Hiawatha Av going southbound.

The determination was made to disengage the vehicle when the vehicle "began to drive away at excessive speeds and failed to stop for the lights and sirens."⁷

Facts of this Case:

Did Officer Walls violate the department's Pursuit Policy?

- Officer Walls aired the reason for the stop.
- Officer Walls aired the direction of the travel.
- Officer Thao cannot be heard on BWC or MVR relaying what the speeds were as they were behind the suspect vehicle.
- Officer Walls can be heard on BWC telling Officer Thao, "if he doesn't stop up here we're gonna discontinue. Stop. Stop. We're done."
- Elapsed time from the lights/sirens being turned on, until the discontinuation of the stop was 1 minutes and 30seconds.

- Officer Walls stated he realized he had made a mistake in failing to air speeds during the flee.

As Chief of Police I am responsible for providing clear expectations on what is acceptable behavior in our workplaces as well as what will not be tolerated. Based on my review of the facts of this investigation and Officer Walls admission that he in fact failed to communicate via his radio the speeds during the flee I am issuing a written reprimand to Officer Walls.
