John Rebholz reported for the Fundraising Committee. With a robust fundraising plan, we have the potential to have a total of \$35,000 available to assist candidates. 2022 golf outing is set for May 14 and the Reagan Rally/Dinner is planned for the fall. Rebholz circulates a sign-up sheet for people willing to contact sponsors for these events. Comments:

• Steve Rader voiced concern about a weak turnout at Reagan Dinner if held after the primary and suggested having it before the primary and including a straw poll.

- Hood Richardson shared that candidates tend to campaign in the Eastern part of our state in the spring.
- Steve Rader suggested a raffle for historic coins conducted during the County/District/State Conventions.

Chair Garris asked the Fundraising committee to reconsider the events and dates and report back within two weeks (The urgent time frame due to the lead time required to execute successful events).

Donna Wortman and Jason Hall were introduced as candidates for open seats on the Executive Committee. Their letters of intent are attached to these minutes. There are currently 7 openings on the committee. Filling these seats will be part of the business of the upcoming County Convention.

The chair reported two resignations received. Gail Breed resigned as Secretary on January 5. Donna Simon resigned as Assistant Secretary on February 5. Therefore we have a vacancy that needs to be filled promptly. Anne Maatman has agreed to serve as Interim Secretary until the county convention on March 5, while continuing to serve as Treasurer.

The chair requested nominations of committed individuals to complete the secretary's term from March 2022-March 2023. To serve as secretary, membership in the Executive Committee is not required. The election will take place at the county convention. As no nominations were made, Steve Rader suggested that all members work to recruit persons to be nominated at the County Convention.

The chair announced the plans for Precinct Officers Training on Saturday, February 26, 2022, at 10 am at Republican Headquarters. This one-hour training is geared to streamline the work of the precinct officers at the Precinct Meetings on March 6. All Beaufort County Republicans are welcome.

The chair announced that the Precinct Meetings/Republican Convention/Candidate Meet and Greet is set for Saturday, March 5, 2022, at Southern Acres, Bath. She asked those in attendance to encourage voters and candidates to attend. The timetable is as follows:

- Steve Rader asked about the meeting with Republican members of the Beaufort County School Board that didn't happen due to a case of COVID. Chair Garris agreed to work on rescheduling it.
- Paul Varcoe reported that during February our office is open 10 am 2 pm Mondays-Fridays.
 In March, hours will be extended to Mondays/Wednesdays/Fridays 10 am 5 pm,
 Tuesdays/Thursdays 10 am 7 pm, and Saturdays 10 am 4 pm. He encouraged volunteers to contact Jody Forest.

NEW BUSINESS:

• Jody Forrest showed the flags and t-shirts available for sale at Headquarters.

- Per the Fundraising Committee's recommendation, the committee approved \$500 seed money for purchasing products to sell at Headquarters. (Motion by Steve Rader, second by John Rebholz)
- Patricia Garrison moved that the Executive Committee consider promoting Republican candidates in the Primary phase possibly via a survey with answers published on our website. After much discussion, Garrison withdrew the motion and moved to form a committee to recommend how to promote candidates in the Primary phase with an interim report at the March convention and a final recommendation at our April meeting. Steve Rader seconded. Motion failed 8-7.
- Steve Rader reported that the GOP platform will be part of the business of the District Convention. He asked us to review the current platform (website) and make suggestions for changes/deletions/additions to him by Saturday, February 12, when the platform committee will meet.
