

## **- 2024 ELECTION PRIMARY INFORMATION -**

In North Carolina, the statewide primary will be held on Tuesday, March 5<sup>th</sup>, 2024. During this election, voters can choose which candidates they prefer to be on the general election ballot in November. The purpose of a primary is to narrow the field of candidates for the general election. This election is also the election for members of the Orange County Board of Education. The Orange County GOP would encourage you to run for these offices, if you qualify.

**Monday, December 4<sup>th</sup>, 2023** - Filing open at Noon for the 2024 Statewide Primary Election. NC GS §163-106.2

**Friday, December 15<sup>th</sup>, 2024** - Filing Closes at Noon for the 2024 Statewide Primary Election. NC GS §163-106.2

**Monday, January 15<sup>th</sup>, 2024** - County board of elections begin mailing absentee ballots for the 2024 statewide primary to eligible voters who submitted an absentee ballot request form. NC GS §163-227.10

**Friday, February 9<sup>th</sup>, 2024** - Civilian voter registration deadline for the 2024 statewide primary ends at 5:00pm. NC GS §163-82.6(d)

**Thursday, February 15<sup>th</sup>, 2024** - One-Stop, in-person voting period begins for the 2024 statewide primary. NC GS §163-227.2(b)

**Tuesday, February 27<sup>th</sup>, 2024** - Deadline for civilians to submit an absentee ballot request for the 2024 statewide primary ends at 5:00pm. NC GS §163-230.1

**Saturday, March 2<sup>nd</sup>, 2024** - One-Stop, in-person early voting ends at 3:00pm for the 2024 statewide primary. NC GS §163-227.2(b)

**Tuesday, March 5<sup>th</sup>, 2024** - Election Day for the 2024 statewide primary and civilian ballot return deadline. Election polls are open from 6:30am to 7:30pm. NC GS §163-1

**Friday, March 15<sup>th</sup>, 2024 at 11:00am** – Orange County board of elections Canvass meeting for May Primary - NC GS §163-182.5

**Tuesday, April 23<sup>rd</sup> or May 14<sup>th</sup>, 2024** – Run-off dates for the 2024 Primary Election. NC GS §163-111(e)
