Why Are You Running?

1. What are the three most important issues facing North Carolina? What are your top priorities in addressing these issues?

Support of Broadband

I voted to lay 52 miles of fiber throughout Person County as a commissioner. As a Representative, I would work to pass common-sense legislation to support Durham and Person counties current and future endeavors of connecting their citizens.

Education

Education is the path to ensure prosperity for our children and our communities.

My grandmother was a teacher and showed me the need to support education at all levels. From teachers and support staff to local school systems and preschool programs, a solid educational foundation provides the best outcomes for our most precious resource, our children.

Agriculture

I come from a family rooted in farming. Agriculture provided a means for my great-grandfather and his children, as it has for so many North Carolina families. As a significant economic driver for the state and the 2nd district, we need to support our farmers with proven programs to preserve and protect our farming tradition.

State Revenues, State Spending, and the Economy

2. Is the current system of state taxation fair? What changes should be made, if any? Please cite specific examples

No I do not believe it is fair, and the republican led tax cuts have set us back as a state and led to increased fees and fines often levied on the poor and middle class. If elected I would support a roll back on those taxes and advocate for tax cuts for working families. I would also support:

- Legislation to allow counties to include specific language on the ballot referendum designating how the proposed quarter-cent local sales tax levy will be spent.
- The introduction and enactment of a state low-income housing tax credit to assist with the construction of housing affordable to people of all income levels.

I would support an increase in funding to reinstate the Drug Court program in counties. As a commissioner I saw the importance of this program for our most vulnerable citizens who were addicted to drugs. They received help and compassion in sentencing to assist them.

I would also support an increase in education to include monies for operating, teacher and support staff salary increases, and capital funding for counties to renovate and build new schools.

4. What is your stance on the state of North Carolina utilizing economic development incentives, such as the One NC and JDIG programs to attract and recruit corporations?

I saw these programs work as a Commissioner in providing an adequate package to a company looking to locate in the state. I am not necessarily a fan of incentives, but we must provide them to maintain competitiveness amongst other states when attracting business. I would work to increase funding for these programs and eliminate the county required match to access these funds.

Secure Elections, Fair Elections, and the Right to Vote

5. What changes need to be made to NC law to protect the right of all people to vote in free and fair elections?

I would support same day registration on election day, and access to more mail in ballots.

Housing

6. What, if anything, should the NC government do to promote affordable housing and home ownership? What specific policies or programs would you use to do that? Do you support downpayment assistance for first time homebuyers? Rent control? Inclusionary zoning? Please detail your answer.

I would support the introduction and enactment of a state low-income housing tax credit to assist with the construction of housing affordable to people of all income levels. I would support a program to assist with first time homebuyers, policies to limit rental increases in a year, and voluntary inclusionary zoning policies.

Assistance programs should be implemented through DHHS and administered by local DSS offices.

Wealth

I support raising the minimum wage to include the tipped minimum wage.

By electing more working class to the general assembly, rather than retired and independent wealthy individuals.

I support funding the federal background check system adequately

Civil Rights and Race Equity

11. What should the state do to promote racial equity and diversity, such as increasing opportunities for under-represented and under-served people of color? Can you provide an example of your advocacy for race-equity and diversity?

I am employed with the non profit RAFI-USA where our mission is working towards a more just food system and agricultural practices. I work as a Policy and Program Manager and directly advocate for BIPOC farmers and socially disadvantaged farmers with regards to federal policy. As a legislator I would look at every proposal through an equity lens.

The Environment

12. Addressing the climate crisis through transformative, intersectional policies will be essential to keeping NC communities safe, healthy, and vibrant. What do you see as the most critical environmental and climate justice issues facing NC and your district? If elected, how would you leverage your role to address them?

With regards to the district one huge concern in Person County is the management of the Duke Energy Ash ponds and our drinking water. Also from a counties concern I would support:

- Legislation to restore county authority over solid waste management and oppose any further shift of authority away from local governments.
- Additional state funding to assist local governments in all recycling, with special attention to managing electronics recycling and scrap tire disposal
- Legislation to help improve water quality in the state, including a
 comprehensive approach to aquatic weed control, increased funding and
 resources for state agencies to develop health advisory levels and
 standards for existing and emerging contaminants.

Duke Energy's monopoly on our utilities has severely curbed the expansion of clean energy across North Carolina and locked us into the expansion of harmful gas plants with disproportionate pollution and cost burdens falling on Black and Brown communities. What creative ideas will you bring to the Legislature to push back against Duke energy to create a more safe, affordable, and resilient electricity sector?

More regulation and oppose policies that would put more power in their hands. I know first hand and I am on record in fighting against Duke Energy pollutants as a commissioner.

As a commissioner I supported the creation of a county-run MRF and employed citizens with special needs through a vocational employment program. I would support additional state funding to assist local governments in all recycling, with special attention to managing electronics recycling and scrap tire disposal. I would evaluate and support policies that continue to work towards climate change and greener jobs.

State and Local Government Relations

15. In what ways should NC preempt local governments? In what ways in which it currently does so should it not?

I generally support more local control EXCEPT in ways it is used to discriminate like we have seen some localities with regards to equality.

Education

As a commissioner I have a strong record of support for community colleges and believe they are the key to communities economic growth.

I would support increased funding in areas of early college programs and dual enrollment, and ways to make public state universities more affordable.

I believe teaching the history around these subjects will go a long way in stopping the proliferation of discriminatory and racist behaviors.
