### **DFA Addresses Some Clam Farm Complaints**

Opponents of a proposed experimental clam farm in Three Fathom Harbour were successful in getting the Department of Fisheries and Aquaculture (DFA) to pay attention to some of the issues that they had raised, but fell short of persuading DNR not to renew the clam farm's license to operate for another year. (Aquaculture License and lease AQ5001).

Murray Purcell first applied for a "special experimental license" in 2017 covering 14.2 hectares through his company, Searise Fisheries Ltd. This license allows the holder to "test or develop new technology or methods, carry out basic research, and test the technical feasibility of an aquaculture site. The holder can choose to apply for a commercial aquaculture licence or lease, going through the normal application process for such leases."


All the residents we spoke with agreed that they had heard nothing about the issuing of this permit until the end of May 2023. The province did publish a request for public comments four times in the Royal Gazette in February 2021, and on its website during the period January 29, 2021, to February 26, 2021. The "Findings and Decision" document approving the license noted that "Zero submissions were received by NSDFA during the 30-day public comment period."

Concerned residents set up the Causeway Road Beach Action Community (CRBAC), gathered petition signatures, arranged meetings with their elected officials, and prepared a detailed 40-page document citing scientific research they believe DFA failed to consider in granting the original license.

DFA does not normally respond to public comments, but DFA Aquaculture Administrator Robert Ceschiutti went through several of the concerns CRBAC had raised, for the most part minimizing or dismissing the concerns. But then Ceschiutti proposed adding five "modifications." Searise Fisheries would have to provide more information to DFA by revising its Farm Management Plan, avoid areas with Eelgrass, add a Wildlife Monitoring Plan to its Farm Management Plan, track interactions with local wildlife, and provide public access for recreational use, while seeking permission to use private property to access the lease site.

Susan Cakmak, one of the founders of CRBAC, told the *Cooperator* that the group welcomed the five lease modifications. "It's good that they took us seriously at least," Cakmak said, "but how do we know the company is going to come up with an adequate farm plan? Who's going to monitor this operation to make sure they're following these conditions?"

Another local resident told the *Cooperator* that DFA had told her that the Farm Management Plan was not available for public review. "It's very difficult for us to have a clear understanding even to know what's going on in our backyard if we can't access the plan. That's also where a lot of friction comes from between the residents and the operator."

#### **Disaster Financial Assistance for July 2023 Floods**

The Province's Disaster Financial Assistance Program is designed to help Nova Scotians, municipalities, small businesses, and not-for-profit organizations get back on their feet after a major storm or natural disaster. Not all disasters are covered by private insurance, and this program helps those whose losses are not insurable. Types of losses can include flood damage and damage to uninsurable items like household appliances, such as washers, dryers and furnaces.

The program covers up to \$200,000 in uninsurable losses per household, small business and not-for-profit organization. Residents are asked to continue to assess damage, keep all receipts, take pictures and video and work with their insurance companies. Disaster financial assistance does not replace private insurance and only uninsurable damage is eligible. People who are not sure if their insurance covers the damage should contact their insurance broker or company, or the Insurance Bureau of Canada at 1-844-227-5422.

#### **Housing Pilot Update**

Work continues on the Eastern Shore Housing Pilot project; we've received responses from over 30 home and property owners. We are working closely with the Department of Housing and Municipal Affairs to determine the next steps.

#### **Home-Sharing Program Expands with Happipad**

Nova Scotians in search of an affordable space to rent now have more options and support. The province's partnership with online home-sharing platform Happipad – launched to help people displaced by wildfires but it's now available to all Nova Scotians with a \$1.3 million investment over two years.

There are an estimated 130,000 vacant bedrooms in Nova Scotia. This pilot expansion is a call to action for those who may have extra space in their homes to consider hosting a person or family in their home. Students, healthcare workers, tradespersons and any others who may need safe, affordable and comfortable short-term accommodation could be matched with a room.

Happipad does thorough background checks, matches renters with hosts, collects and distributes the rent, and provides dispute resolution in case of host or renter concerns.

#### **Funding for Sustainable Communities Initiatives**

Congratulations to MusGo Rider! Through the province's Sustainable Communities Challenge Fund, non-profit organization MusGo Rider will receive \$130,400 to install solar panels to power electric vehicle chargers and its office building. It will also be used to retrofit the building to reduce greenhouse gas emissions by 589 tonnes of carbon dioxide per year.

This fund is available to municipalities, non-profit and community organizations, post-secondary institutions, and First Nations communities to help them respond to, prepare for and fight climate change.

#### **Health Care Highlights**

## Doctors of Nova Scotia Reach New Four-Year Collective Agreement with the Province

Doctors Nova Scotia and the province have successfully negotiated new, four-year physician and clinical agreements. The contracts cover doctors' compensation and benefits as well as funding for clinical and academic responsibilities.

A new payment model option for family physicians will increase their compensation based on the hours worked, the services they provide and the number of patients in their practices.

Family physicians compensated through fee for service will be eligible for a grant and will receive an annual payment based on their number of patients.

There is also funding in the agreement for family physicians to hire allied healthcare providers, such as physiotherapists and dietitians, in their offices.

Other investments through the agreements will help:

- improve access to regional specialty services and reduce the surgical wait list
- support training the next generation of physicians
- support physician recruitment and retention.

#### **Nurses Ratify Collective Agreement**

Nurses have voted to accept a five-year contract with the province. The Nova Scotia Council of Nursing Unions represents a total of over 10,000 LPNs, RNs and nurse practitioners in the Nova Scotia Nurses Union, NSGEU, CUPE and Unifor.

87.5 per cent of those who voted supported the new agreement that was reached during conciliation.

The agreement offers a competitive wage package that should help retain nurses and potentially recruit nurses from outside the province.

#### **New LifeFlight Airplane Unveiled**

A new Emergency Health Services LifeFlight plane will soon transport non-critical care patients from Yarmouth and Sydney to Halifax for tests and treatment. The new service will free up ambulances and paramedics for local emergency calls – reducing wait times – and saving patients hours of travel by

The plane will carry two to four patients per trip, beginning with three round trips daily. That means up to 12 ambulances a day will be staying in communities. LifeFlight critical care aircraft (one plane and two helicopters) complete about 1,200 air medical missions each year.

#### **New Master's Program to Train Physician Assistants**

The province announced a new physician assistant program at Dalhousie to begin in January 2024. The two-year master's program will be open to 24 students. Priority will be given to Nova Scotian applicants who meet the program's eligibility criteria. This will be the first physician assistant program in Atlantic Canada and one of only four in the country.

Physician assistants provide safe, competent and effective healthcare under the supervision of physicians. They can:

- perform histories and physical examinations
- order blood and radiological tests
- make diagnoses and outline treatment plans
- assist with surgeries
- perform minor surgical procedures
- consult other medical and health services
- prescribe medication
- attend to medical emergencies such as cardiac arrest
- provide counselling and preventive services
- administer vaccinations
- perform educational, research and administrative functions.
