Amanda Cashin: Photographer and Tour Co-founder

Earlier this fall, I drove down Highway 207 to attend the Surfside Studio Tour. "Sweeping dunes, vast salt marshes and crashing waves will greet you" as you drive this route," says the Surfside brochure. The talented photographer Amanda Cashin is one of the organizers of this Tour that included twenty-five artists at sixteen locations!



In Three Fathom Harbour, Cashin displayed her distinctive, colourful photographs and cards, with pottery from Muddy Squirrel Studios and yarns from Three Fathom Fibre Arts. The Eastern Shore is blessed to have so many wonderful artists and crafters.

Cashin grew up on the Eastern Shore in Charlos Cove, near Guysborough, with the ocean nearby. "I spent a lot of time in boats and on beaches with my dad when I was little and the ocean is home to me," Cashin told me in an interview. She later lived in Halifax, but when she chose to leave the city, she decided on Lawrencetown. It "just felt like the place I belonged," she said. "I can't imagine living where I couldn't see the ocean every day."

From elementary into high school, Cashin loved writing short stories and essays. When she was about 9 years old, she wished she had a camera because she would look at things and frame them in interesting compositions. "I didn't get my first camera until I was 15," she said, and "didn't start selling any of my photos until about 13 years ago" in 2011.

When I ask Cashin about her influences, she said that her mother and sister were very creative, always working on sewing, knitting, or needlework projects. Her main influence for photography, though, was magazines images. She was "inspired by the photographers who were able to help people see things – outside their day-to-day view – images that make the viewer take a second to think about what they are seeing." On a recent trip to Kenya, Africa, Cashin affirmed things about herself as a photographer. One day she and 5 or 6 photographers "were taking pictures of a famous elephant in Amboseli." For her, it wasn't about capturing the elephant but noticing small details and textures. "I came away with a photo that shows how the elephant's back mirrored the shape and texture of Mount Kilimanjaro in the background. I like to make people think about what they are viewing. I will always photograph a dramatic sky, or lupins in July, but my favorite images are the ones with a pattern, interesting line, or shadow."

Her first sale was in 2011 when, she says, "someone took a chance on me!" Since then, she's been selling her work in different galleries and shops.



HRM & NS PROPERTY TAX PROGRAMS

The municipality has a variety of programs to aid homeowners with their property tax obligations. There are various options for payment plans, property tax rebates, or deferral of property taxes (payment is put off to a later date). A homeowner with a LIC (Local Improvement Charge) can also apply for a deferral of these charges. It is important that you know what choices exist. Some of these programs are available to homeowners with a combined household income of \$34,000 or less a year. Deadline to apply is December 31. The application form can be found at www.halifax. ca/sites/default/files/documents/about-halifax/ AffordableAccessApplicationForm_2.pdf.

Furthermore, seniors should know that there is a NS Provincial Property Tax Rebate for Seniors Program. This program is for those who have been received the Guaranteed Income Supplement in January of the application year. Criteria requires you to have paid your property taxes from the prior year in full. A receipt from HRM showing property taxes are paid in full is required. Applicants to this program can receive a rebate on half of their taxes paid to a maximum of \$800. The study will help improve the municipality's understanding of professional art venue operations, identify challenges facing existing art venues, identify the needs of the local arts and culture community and inform the municipality's long-term approach to supporting, renewing and investing in professional arts venues.

As part of the Performing & Visual Arts Venues Study's engagement program, Happy Cities, the firm conducting the study, is seeking feedback from users of performing and arts venues on their experience with these facilities. Happy Cities is also releasing a second survey to collect input from Indigenous peoples and artists. There are two surveys available: a Public Survey and an Indigenous Residents Survey. HFXGO TRANSIT MOBILE PHONE APP

HRM has launched a new Halifax Transit mobile fare payment application, allowing customers to purchase and use fare products from the convenience of their smartphones. The app is provided by Masabi smart ticketing and fare payment solutions, HFXGO is a Halifax Transit branded version of Masabi's JustRide app, which has been implemented by transit agencies of all

sizes worldwide HEXGO is now available at the Apps Store for iOS and Google/Android devices.
Users of the app simply need to purchase their desired ticket or pass, activate the ticket or pass, and show it to the Transit Operator or ferry security staff just prior to boarding. Passengers can still purchase paper tickets and passes or use cash fare. This project involves two phases, phase 1 being the mobile app, and phase 2 being the installation of onboard validators. HRM TO APPOINT ESLSC ARCHITECT
Back in August, HRM issued a RFP "Request
For Proposals" #23-182 for Design Consulting Services for the Eastern Shore Life Styles Centre, to replace the old Lions Centre in Sheet Harbour. 13 architectural firms submitted bids for consideration. After careful review, one firm is being recommended to do the work. HRM will soon be announcing the award winner. Residents will have the opportunity to review and share their thoughts on the design concept through multiple in-person public engagements sessions that will take place in early 2024. Construction is expected to break ground in the Spring of 2025. AFFORDABLE EVENT INSURANCE

Organizers of community events have had to either scale back or cancel events because they couldn't afford appropriate insurance. To address this issue, the municipality reached out to its insurance broker; AON Risk Solutions, to create the Citizen Event Insurance Program (CEIP) which provides affordable access to a \$2-million commercial general liability policy with additional coverage for event organizers. Community groups or associations can also purchase insurance through this program for liability coverage of annual activities, operations and programming.
