JOINT MOTION TO STAY PROCEEDINGS

Plaintiffs Danielle Jaymes; PWGG, L.P.; John Phillips; National Rifle Association of America; Firearms Policy Coalition, Inc.; and Second Amendment Foundation and Defendant Rob Bonta, in his official capacity as Attorney General of the State of California, hereby respectfully move this Court for an order staying all proceedings in this case and vacating the Scheduling Order, Doc. 26 (Jan. 21, 2026).

In support of their motion, the Parties state as follows:

1. On October 13, 2025, Plaintiffs filed the operative complaint alleging that California Assembly Bill 1127 violates the Second Amendment because it bans handguns that are in common use for lawful purposes. *See* Doc. 1.

2. The parties are currently in discussions that could lead to the resolution of this case. To allow those discussions to go forward and to preserve both the Court’s resources and those of the Parties, the Parties respectfully request the current schedule be vacated.

WHEREFORE, the Parties respectfully request the Court to stay all proceedings and deadlines in this case.
