#### **JOINT APPLICATION FOR A STAY**

Petitioners, Landmark Firearms LLC, US Rifle, LLC, Polymer 80, Inc., and Firearms Policy Coalition, Inc., by and through their counsel, Joshua Prince, Esq. and Respondent Commissioner Evanchick, by and through his counsel, Nicole Boland, Esq., jointly request, pursuant to Pa.R.A.P. 123, that this matter be stayed and aver in support:

- 1. On December 20, 2019, Petitioners filed the underlying Petition for Review and Application for an Emergency Preliminary Injunction.
- 2. On January 10, 2020, this Court issued an Order scheduling a hearing for January 21, 2020, on Petitioners' Application for an Emergency Preliminary Hearing.

- 3. On January 31, 2020, then-Judge Kevin Brobson issued a Memorandum Opinion and Order granting Petitioners' Preliminary Injunction and requiring Petitioners to submit a bond of \$100.00 for the Order to become effective.
- 4. On February 3, 2020, Petitioners posted the \$100.00 cost bond.
- 5. On February 24, 2020, Respondent filed an Answer with a new matter.
- 6. On Mach 23, 2020, Petitioners filed an Answer to Respondent's new matter.
- 7. On March 25, 2022, this Court issued a rule to show cause, directing the Petitioners to respond to why the case should not be dismissed for want of prosecution.
- 8. In response, counsel for the Parties conferred and given the recent promulgation of federal regulations and the Pennsylvania State Police's intentions to promulgate state regulations related to the underlying issue before this Court, <sup>1</sup> for judicial economy and that of the Parties, since any promulgated regulations may have an impact on any final decision rendered by this Court, the Parties respectfully request that this case be stayed for 120 days for the Pennsylvania State Police to determine whether it will promulgate a regulation and if so, to institute and finalize any rulemaking.

**WHEREFORE**, the Parties jointly and respectfully request that the Court stay this matter for 120 days.
