18	On October 19, 2022, the parties filed a Joint Motion and Stipulation	
19	Concerning Plaintiffs' Voluntary Dismissal of Counts Two Through Seven of the	
20	Second Amended Complaint and the Filing of a Third Amended Complaint	
21	("Stipulation"). Having reviewed the Stipulation and good cause appearing, the	
22	Court ORDERS as follows:	
23	1. As to Counts Four, Five,	Six, and Seven of the Second Amended
24	Complaint, in accordance with the previous Order on Joint Motion and	
25	Stipulation Regarding Plaintiffs' claims challenging Senate Bill 1327	
26	(<i>see</i> Dkt. No 60):	
27	a. Plaintiffs Lar	a Rae Renna, Danielle Jaymes, Laura
28	Schwartz, Mi	chael Schwartz, Robert Macomber, Clint

1	Freeman, John Klier, Justin Smith, John Phillips, Cheryl	
2	Prince, Darin Prince, Ryan Peterson, and Leonard Ruebe	
3	shall dismiss these counts with prejudice; and	
4	b. Plaintiffs PWGG, L.P., North County Shooting Center,	
5	Inc., Gunfighter Tactical, LLC, Firearms Policy Coalition,	
6	Inc., San Diego County Gun Owners PAC, Citizens	
7	Committee for the Right to Keep and Bear Arms, and	
8	Second Amendment Foundation shall dismiss these counts	
9	without prejudice.	
10	2. All Plaintiffs shall dismiss Count Two of the Second Amended	
11	Complaint without prejudice.	
12	3. All Plaintiffs shall dismiss Count Three of the Second Amended	
13	Complaint without prejudice.	
14	To effect the above dismissal of claims, Plaintiffs shall file a Third Amended	
15	Complaint on or before October 31, 2022, pursuant to FRCP Rule 15 (a)(2), and	
16	Defendants' response to the same shall be due on or before November 14, 2022.	
17	Plaintiffs' Third Amended Complaint shall not add or amend any substantive	
18	allegations other than to effect the above dismissal.	
19	Based on the foregoing stipulation, Defendants' pending motion to dismiss	
20	Count Three for failure to state a claim (Dkt. No. 62) is denied without prejudice as	
21	moot.
