Position Summary:

The Clinical Director is a key leadership role, which in collaboration with the Chief Executive officer, will work in ensuring that First Step clinical programs are client focussed, of the highest and ethical standard, evidence-based and compliant with all relevant clinical governance directives and guidelines.

The Clinical Director will be an active member of the clinical team and serve as a role model and lead in the professional delivery of health services.

The Clinical Director will provide expert opinion and guidance to the Clinical Governance Advisory Board to confirm appropriate governance and inform strategic thinking and planning to support the growth and development of First Step clinical programs.

Key challenges:

The Clinical Director role is a new leadership position within First Step and therefore, the person will be responsible for implementing a clinical template to meet the current and future operations in clinical services across an existing multi-disciplinary health team.

Work collaboratively with the non-clinical staff. Develop, update and implement clinical procedures) in collaboration with relevant colleagues, and in accordance with relevant standards. Work with the Operations Manager to ensure that First Step meets the clinical standards for accreditation and other clinical audits. Ensure Medicare billing is compliant with Medicare standards. Provide secondary consultation to colleagues. Participate and provide clinical oversight to First Step's clinical research and evaluation projects. Maintain a client load collaboration with the multi-disciplinary team. Represent First Step in relevant external forums. Convene weekly Client Review meetings and case conferences as required.
